AGENDA HEADING:

Ordering construction of the following: Demolition of Former Public Works Facility at 216 SE 5th Street and 108 SE 5th Street - Receiving bids, (6-13-23), and Setting date of hearing, (6-26-23). (Construction Estimate - \$775,000).

SYNOPSIS:

Recommend the City Council order construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. The project includes the demolition of designated buildings, structures, and pavements located at 216 SE 5th Street and 108 SE 5th Street.

This project is required in order to prepare the properties for disposition and redevelopment of the Market District, in accordance with the terms of the Urban Renewal Development Agreement between the City and The District Developer, LLC. After the structures and improvements are removed, the parcels will be converted to greenspace until redevelopment occurs.



The work includes the removal and disposal of regulated hazardous materials and demolition of designated buildings, structures, and pavements, all in accordance with the contract documents, including Plan File No. 655-086/093, located at 216 SE 5th Street and 108 SE 5th Street and 108 SE 5th Street, Des Moines.
- The estimated cost of demolition is \$775,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
- This project is anticipated to be completed in the fall of 2023.
