Approval of purchase of a one (1)-year subscription for Information Technology (IT) research and advisory services from Gartner Group, Inc. (56 Top Gallant Road, Stamford, CT, 06902, Eugene A. Hall, President), per State of Minnesota NAPSO Valuepoint Master Agreement No. 186840 between Gartner, Inc. and the State of Minnesota, which was competitively bid; State of Iowa contract #2021BUS0531, and City of Des Moines Short Form No. K23-003.

SYNOPSIS:

Gartner is a research and advisory company with particular depth in technology research. A Gartner IT Research and Advisory Services subscription provides City staff access to a network of professional analysts having vast research and knowledge of technologies in which City staff have limited experience. Their "Executive Program" offers access to research, advice, strategic planning tools, peer networking, and similar resources to continuously align technology priorities and organizational performance. Their analysts will meet regularly with the Chief Information Officer (CIO) and City Manager to help the City navigate strategies and choices around utilizing technology investments to execute the organization's goals and reduce financial risks. In particular, their assistance will help the City accelerate IT project portfolio governance, Request for Proposal (RFP) writing, contract review, and price negotiation for essential technology upgrades.

The one (1)-year subscription will begin July 1, 2023, and end June 30, 2024.
