

ADDITIONAL INFORMATION:

- On May 8, 2023, by Roll Call No. 23-0678, the City Council approved plans and specifications for the North Valley Drive and Grand Avenue Sidewalk and Railroad Crossing Improvements project and designated the lowest responsible bidder as TK Concrete, Inc. for \$580,895.
- This project provides for the construction of new sidewalks along North Valley Drive between the Bill Riley Trail and 56th Street. The project also replaces the approach paving and sidewalks at the North Valley Drive and Grand Avenue railroad crossings of Iowa Interstate Railroad's tracks. The project is in coordination with the Iowa Interstate Railroad, who will be replacing the surface panels and railroad ties to improve the condition of the railroad crossings.
- The Construction and Maintenance Agreement provides that the Iowa Interstate Railroad will replace the existing railroad crossing panels with new concrete crossing panels in coordination with the City's crossing improvements project at North Valley Drive, and the City shall reimburse the railroad for those costs.
