# AGENDA HEADING:

Ordering construction of the following: 1851 Hartford Avenue Grading and Restoration - Receiving bids, (10-3-23), and Setting date of hearing, (10-23-23). (Construction Estimate - \$270,000).

#### SYNOPSIS:

Recommend the City Council order construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. This project provides for the grading and restoration of City-owned property located at 1851 Hartford Avenue. Excess suitable embankment material from the site at 1851 Hartford Avenue will be utilized for shoulder improvement work at the northeast corner of Fleur Drive and Bronze Street.



# **ADDITIONAL INFORMATION:**

- The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 1851 Hartford Avenue Grading and Restoration, Activity ID 04-2023-018. The improvement includes Class 10 and Class 13 Excavation, erosion control, seeding, tree planting, and other incidental items, all in accordance with the contract documents, including Plan File No. 655-248/265 located at 1851 Hartford Avenue, Des Moines, Iowa.
- The estimated construction and restoration cost is \$270,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
- The project is anticipated to be completed in the spring 2024.
