### **AGENDA HEADING:**

Approving application to the Iowa Department of Agriculture and Land Stewardship (IDALS) for a Water Quality Initiative Targeted Demonstration Watershed Project Grant for \$100,000 for Soil Quality Restoration Project.

#### **SYNOPSIS:**

Recommend approval of application to IDALS for a grant in the amount of \$100,000 to help fund a soil quality restoration project at total estimated cost of \$230,000.

# **FISCAL IMPACT:**

Amount: \$230,000

<u>Funding Source</u>: 2023-2024 Operating Budget, Page 221, Public Works, National Pollutant Discharge Elimination System (NPDES), PW248424 (\$130,000 Stormwater Utility revenue, \$100,000 IDALS grant)

#### **ADDITIONAL INFORMATION:**

- The Public Works Department currently manages the Stormwater Best Management Practices program which provides funds to private property owners to install various eligible stormwater management practices which reduce runoff and improve water quality of runoff.
- Soil Quality Restoration is a practice typically applied to established lawns, using deep core aeration and applying a layer of compost to reduce the need for lawn fertilizers and watering and increase the capacity of the existing soil to soak up and retain stormwater.
- It is recommended by the Public Works Department that implementation of Soil Quality Restoration should be increased because it is one of the easiest and most cost-effective stormwater management practices that individual homeowners.
- The IDALS grant will allow the City to develop a larger project to reduce barriers to residents who wish to participate to install soil quality restoration on their property within identified priority watersheds.
