AGENDA HEADING:

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended, by adding 42-567, 42-568, 42-569, 42-570, 42-571, and 42-572, relating to the enforcement of nuisance vegetation management.

SYNOPSIS:

Add an Article into Chapter 42 – Environment to enable the City to enforce against nuisance tall grass and weeds. This enforcement would displace a program previously managed by Polk County, whose involvement ceased this past November.

FISCAL IMPACT:

Amount: \$110,000

Funding Source: NS041042 - 527620

ADDITIONAL INFORMATION:

- During the past 2023 season, enforcement of nuisance tall grass and weeds was a joint effort with the City handling inspections on complaints, Polk County issuing notices of violation by their authority, and the City contracting out for the abatement mowing of non-compliant properties.
- For the upcoming 2024 season, in order to assume the entirety of the program from Polk County, the City must adopt Code language to enable its complete enforcement of nuisance vegetation namely tall grass and weeds.
- Comments and input from the City Council work session on January 8, 2024, have been incorporated into the proposed Code language.
