#### **AGENDA HEADING:**

Hearing on SW 56th Street Rehabilitation from Leland Avenue to Wolcott Circle: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as InRoads, LLC, Joseph J. Manatt, CEO, \$411,711.

### **SYNOPSIS:**

This is a public hearing to allow for public input on the SW 56th Street Rehabilitation from Leland Avenue to Wolcott Circle and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project provides for the pavement rehabilitation, including milling, patching, and Hot Mix Asphalt (HMA) overlay along Leland Avenue and SW 56th Street from Highway 28 to approximately 500 feet north of Wolcott Circle.



## ADDITIONAL INFORMATION:

• On March 4, 2024, under Roll Call No. 24-0307, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the SW 56th Street Rehabilitation from Leland Avenue to Wolcott Circle. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the SW 56th Street Rehabilitation from Leland Avenue to Wolcott Circle, Activity ID 06-2024-005. The improvement includes scarification, furnish and place HMA pavement, pavement markings, Portland Cement Concrete (PCC) pavement, pavement removal, traffic control, and other incidental items, all in accordance with the contract documents including Plan File No. 662-043/068 located along Leland Avenue and SW 56th Street from Highway 28 to approximately 500 feet north of Wolcott Circle and other locations as directed by the City Engineer.

- Sealed bids for said improvement were submitted by the following bidders:
  - o InRoads, LLC, Des Moines, IA Low Bid
  - o Grimes Asphalt and Paving Corporation, Des Moines, IA
  - o OMG Midwest, Inc. dba Des Moines Asphalt & Paving, Ankeny, IA
- The bids were received and opened at a public meeting presided over by the City Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, IA, at 11:00 a.m. on March 19, 2024.
- The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by InRoads, LLC (Joseph J. Manatt, CEO, 4761 NE 20th Lane, Des Moines, IA 50313) in the amount of \$411,711, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
- Construction of this project is anticipated to be completed by fall of 2024.
