

ORDINANCE NO. 13,554

AN ORDINANCE to amend the Municipal Code of Des Moines, 1991, adopted by Ordinance No. 11,651, passed April 15, 1991, as heretofore amended, by repealing subsection (5) of Section 2-68 and Section 2-79 thereof, and by adding and enacting a new subsection (11) to Section 2-34 and a new Article VI-E to Subchapter 3 of Chapter 2 consisting of Section 2-126.30, all relating to the creation of a new Information Technology Department to replace the Data Processing Division of the Finance Department.

BE IT ORDAINED by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of Des Moines, 1991, adopted by Ordinance No. 11,651, passed April 15, 1991, as amended by Ordinance No. 11,721 passed September 23, 1991, as amended by Ordinance No. 12,059 passed October 25, 1993, as amended by Ordinance No. 13,214 passed July 24, 1995, as amended by Ordinance No. 13,357 passed July 15, 1996, as amended by Ordinance No. 13,449 passed April 7, 1997, be and is hereby amended by repealing subsection (5) of Section 2-68 and Section 2-79 thereof, and by adding and enacting a new subsection (11) to Section 2-34 and a new Article VI-E to Subchapter 3 of Chapter 2 consisting of Section 2-126.30, all relating to the creation of a new Information Technology Department to replace the Data Processing Division of the Finance Department, as follows:

2-34. ORGANIZATION OF CITY DEPARTMENTS AND OFFICES.

The administrative services and functions of the city, under the city manager, are hereby organized into 11 separate departments as follows:

(11) **Information Technology Department.** The information technology department shall be under the supervision of the Information Technology Director.

2-68. SUPERVISE DEPARTMENT OF FINANCE DIVISIONS.

The director of finance shall supervise the department of finance which shall be composed of the following divisions:

ARTICLE VI-E. INFORMATION TECHNOLOGY DEPARTMENT

2-126.30 SUPERVISION AND RESPONSIBILITY. The information technology director shall supervise the information technology department. The information technology department shall be responsible for:

- (1) planning, development, installation and replacement, as needed, of information systems and equipment;
- (2) network management and support of technology applications and equipment that is presently, or may potentially be connected in the future, to the network system.
- (3) implementing and maintaining a comprehensive and cost-effective communication and information management system that supports and optimizes the delivery of services to internal and external customers.

Sec. 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
