

ORDINANCE NO. 13,566

AN ORDINANCE to amend the Municipal Code of Des Moines, 1991, adopted by Ordinance No. 11,651, passed April 15, 1991, as heretofore amended by repealing Sections 27-319.03, 27-1911.01 and 27-1930.01 thereof and enacting new Sections 27-319.03, 27-2895, and 27-2910.01, all relating to traffic regulation changes.

Be It Ordained by the City Council of the City of Des Moines,

Iowa:

Section 1. **27-319.03. FOUR-WAY STOP INTERSECTIONS--LOCATIONS DESIGNATED.**

The following intersections are hereby designated as four-way stop intersections. Stop signs shall be installed and maintained at the following intersections and the driver of a vehicle approaching these intersections from all directions shall stop in accordance with this chapter before entering the intersections:

**27-2895. GRAND AVENUE--FIFTEENTH STREET TO SEVENTEENTH STREET.**

Grand Avenue, on the south side, from Fifteenth Street to a point 270 feet west thereof, four hour meters, 9:00 A.M. to 6:00 P.M.

Grand Avenue, on the south side, from a point 370 feet west of Fifteenth Street to a point 25 feet east of Seventeenth Street, four hour meters, 8:00 A.M. to 6:00 P.M.

Grand Avenue, on the north side, from Sixteenth Street to a point 150 feet east of Seventeenth Street, four hour meters, 8:00 A.M. to 4:00 P.M.

**27-2910.01. LOCUST STREET--FIFTEENTH STREET TO SEVENTEENTH STREET.**

Locust Street, on the north side, from a point 15 feet west of Fifteenth Street to a point 290 feet west thereof, four hour meters, 9:00 A.M. to 6:00 P.M.

Locust Street, on the north side, from a point 360 feet west of Fifteenth Street to a point 160 feet east of Seventeenth Street, two hour meters, 9:00 A.M. to 6:00 P.M. Sec. 2. This ordinance shall be in full force and effect from

and after its passage and publication as provided by law.
