

ORDINANCE NO. 13,570

AN ORDINANCE to amend the Municipal Code of Des Moines, 1991, adopted by Ordinance No. 11,651, passed April 15, 1991, and amended by Ordinance No. 11,953, passed March 15, 1993, and amended by Ordinance No. 12,011, passed June 28, 1993, and amended by Ordinance No. 12,071, passed December 20, 1993, and amended by Ordinance No. 13,018, passed April 4, 1994, and amended by Ordinance No. 13,143, passed January 23, 1995, and amended by Ordinance No. 13,283, passed December 18, 1995, and amended by Ordinance No. 13,321, passed April 1, 1996, by repealing Sections 15-179 and 15-180, thereof and enacting new Sections 15-179 and 15-180, all relating to park shelter rental fees and Birdland Park Marina Moorage rates.

Be It Ordained by the City Council of the City of Des Moines,

Iowa:

Section 1. That the Municipal Code of Des Moines, 1991, adopted by Ordinance No. 11,651, passed April 15, 1991, and amended by Ordinance No. 11,953, passed March 15, 1993, and amended by Ordinance No. 12,011, passed June 28, 1993, and amended by Ordinance No. 12,071, passed December 20, 1993, and amended by Ordinance No. 13,018, passed April 4, 1994, and amended by Ordinance No. 13,143, passed January 23, 1995, and amended by Ordinance No. 13,283, passed December 18, 1995, and amended by Ordinance No. 13,321, passed April 1, 1996, be and is hereby amended by repealing Sections 15-179 and 15-180 thereof and enacting new Sections 15-179 and 15-180, all relating to park shelter rental fees and Birdland Park Marina Moorage rates, as follows:
