

ORDINANCE NO. 13,778

AN ORDINANCE to amend the Municipal Code of Des Moines, 1991, adopted by Ordinance No. 11,651, passed April 15, 1991, and amended by Ordinance No. 11,953, passed March 15, 1993, and amended by Ordinance No. 12,071, passed December 20, 1993, and amended by Ordinance No. 13,022, passed April 4, 1994, and amended by Ordinance No. 13,161, passed February 27, 1995, and amended by Ordinance No. 13,172, passed April 17, 1995, and amended by Ordinance No. 13,283, passed December 18, 1995, and amended by Ordinance No. 13,315, passed March 18, 1996, and amended by Ordinance No. 13,417, passed January 27, 1997, and amended by Ordinance No. 13,556, passed January 5, 1998, and amended by Ordinance 13,660, passed November 16, 1998 by repealing Section 15-178 thereof and enacting a new Section 15-178, all relating to golf course fees.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. 9 holes - weekday\$ 13.00

18 holes - weekday\$16.00

Weekdays are Monday through Thursday.

9 holes - weekend\$15.00

18 holes - weekend \$20.00

Weekends are Friday, Saturday and Sunday.

Twilight rate

(2 play after 4:00 P.M. on Saturday and Sunday) \$22.00

3rd nine rate \$ 9.00

4th nine rate \$ 11.00

Junior and Senior Rates

Grandview Waveland & Blank

9 holes \$8.00 \$ 10.00

18 holes \$10.00 \$12.00

The above fees are total costs which include irrigation charge, reservation, and tax.

(Junior and senior rates are not available on rounds which begin on Friday afternoon, or all day Saturday and Sunday)

High School Golf Team Fees

\$1.00 per person per practice round

SEASON BADGES

All badges are valid for play Monday, Tuesday, Wednesday, Thursday and rounds beginning before noon on Fridays.

Irrigation Charge -

\$2.00 per round for Senior badgeholders, Senior Husband and Wife badgeholders and Junior badgeholders.
