

ORDINANCE NO. 13,858

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, by repealing Sections 114-319.04, 114-2212, 114-2937, 114-3225 and 114-3264 thereof and enacting new Sections 114-319.04, 114-2212, 114-2937, 114-3225 and 114-3264, relating to traffic and vehicle regulations.

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, is hereby amended by repealing Sections 114-319.04, 114-2212, 114-2937, 114-3225 and 114-3264 thereof and enacting new Sections 114-319.04, 114-2212, 114-2937, 114-3225 and 114-3264, relating to traffic and vehicle regulations, as follows:

Sec. 114-319.04. Location of five-way stop intersections.

The following intersections are designated as five-way stop intersections. Stop signs shall be installed and maintained at the following intersections, and the driver of a vehicle approaching these intersections from any direction shall stop in accordance with this chapter before entering the intersections:

Sec. 114-2212. Garfield Avenue.

Garfield Avenue, at Dixon Street, stop.

Garfield Avenue, at East Twenty-fourth
Street, stop.

Garfield Avenue, at East Twenty-fifth Court,
stop.

Garfield Avenue, at East Twenty-sixth Court, stop.

Garfield Avenue, from the east curbline of East Twenty-seventh Street to the west curbline of East Twenty-ninth Street, stop.

Garfield Avenue, at East Thirty-second Street, stop.

Sec. 114-2937. Forty-eighth Place--Hickman Road to Madison Avenue.

Forty-eighth Place, on the east side, from Hickman Road to a point 270 feet north of Euclid Avenue and any part of the cul-de-sac, no parking any time.

Forty-eighth Place, on the west side, from Douglas Avenue to a point 50 feet north thereof, no parking any time.

Forty-eighth Place, on the east side, from Douglas Avenue to Madison Avenue, no parking any time.

Forty-eighth Place, on the west side, from Madison Avenue to a point 75 feet south thereof, no parking any time.

Forty-eighth Place, on the west side, from Urbandale Avenue to a point 110 feet north thereof, no parking any time.

Sec. 114-3225. Garfield Avenue--East Ninth Street to East Thirty-seventh Court.

Garfield Avenue, on the south side, from East Ninth Street to Idaho Street, no parking any time.

Garfield Avenue, on the south side, from Idaho Street to a point 100 feet east thereof, passenger loading and unloading.

Garfield Avenue, on the south side, from a point 100 feet east of Idaho Street to a point 100 feet east thereof, bus loading and unloading.

Garfield Avenue, on the north side, from a point 75 feet west of East Thirteenth Street to a point 75 feet east of East Thirteenth Street, no parking any time.

Garfield Avenue, on the north side, from a point 50 feet west of East Fourteenth Street to a point 50 feet east of East Fourteenth Street, no parking any time.

Garfield Avenue, on the south side, from a point 200 feet east of Idaho Street to East Fifteenth Street, passenger loading and unloading.

Garfield Avenue, on the north side, from East Seventeenth Street to McCormick Street, no parking any time.

Garfield Avenue, on the south side, from East Fifteenth Street to East Eighteenth Street, no parking any time.

Garfield Avenue, on the north side, from Idaho Street to East Fifteenth Street, no stopping or standing 7:00 a.m. to 5:00 p.m. school days.

Garfield Avenue, on the north side, from a point 30 feet west of Dixon Street to a point 60 feet east of Dixon Street, no parking any time.

Garfield Avenue, on the south side, from East Twenty-second Street to Avenue Frederick M. Hubbell, no parking any time.

Garfield Avenue, on the south side, from a point 50 feet west of East Twenty-third Street to a point 50 feet east of East Twenty-third Street, no parking any time.

Garfield Avenue, on the north side, from Avenue Frederick M. Hubbell to a point 120 feet east of East Twenty-fifth Street, no parking any time.

Garfield Avenue, on the south side, from East Twenty-fifth Street to East Thirty-third Street, no parking any time.

Garfield Avenue, on the south side, from East Thirty-fourth Street to East Thirty-sixth Street, no parking any time.

Garfield Avenue, on the north side, from East Thirty-fifth Street to a point 50 feet east thereof, no parking any time.

Garfield Avenue, on the north side, from East Thirty-seventh Street to East Thirty-seventh Court, no parking any time.

Garfield Avenue, on the south side, from East Thirty-seventh Court to a point 50 feet west thereof, no parking any time.

Sec. 114-3264. Grand Avenue--Thirty-fifth Street to Forty-second Street.

Grand Avenue, on both sides, from Thirty-fifth Street to a point 200 feet west of Thirty-seventh Street, no parking any time.

Grand Avenue, on the south side, from a point 200 feet west of Thirty-seventh Street to a point 50 feet east of Thirty-eighth Place, no parking Monday through Saturday.

Grand Avenue, on the south side, from a point 50 feet east of Thirty-eighth Place to a point 50 feet west of Thirty-eighth Place, no parking any time.

Grand Avenue, on the south side, from a point 50 feet west of Thirty-eighth Place to

a point 50 feet east of Tonawanda Drive, no parking Monday through Saturday.

Grand Avenue, on the south side, from a point 50 feet east of Tonawanda Drive to a point 50 feet west of Tonawanda Drive, no parking any time.

Grand Avenue, on the south side, from a point 50 feet west of Thirty-eighth Place to a point 240 feet east of Tonowanda Drive, no parking Monday through Saturday.

Grand Avenue, on the south side, from a point 165 feet east of Tonowanda Drive to a point 75 feet east thereof, no parking any time.

Grand Avenue, on the south side, from a point 50 feet east of Tonowanda Drive to a point 115 feet east thereof, no parking Monday through Saturday.

Grand Avenue, on the south side, from Forty-second Street to a point 50 feet east thereof, no parking any time.

Grand Avenue, on the north side, from a point 200 feet west of Thirty-seventh Street, to a point 50 feet east of Thirty-ninth Street, no parking Monday through Saturday.

Grand Avenue, on the north side, from a point 50 feet east of Thirty-ninth Street, to a point 50 feet west of Thirty-ninth Street, no parking any time.

Grand Avenue, on the north side, from a point 50 feet west of Thirty-ninth Street, to a point 50 feet east of Fortieth Street, no parking Monday through Saturday.

Grand Avenue, on the north side, from a point 50 feet east of Fortieth Street to a point 50 feet west of Fortieth Street, no parking any time.

Grand Avenue, on the north side, from a point 50 feet west of Fortieth Street to a point 220 feet east of Forty-second Street, no parking Monday through Friday.

Grand Avenue, on the north side, from Forty-second Street to a point 220 feet east thereof, no parking any time.

Sec. 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
