

ORDINANCE NO. 13,870

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance No. 13,841, passed July 24, 3000, is hereby amended by repealing Sections 114-2684, 114-2943, 114-3444, 114-3452, 114-3466, 114-3468, 114-3792, and 114-3926 thereof and enacting new Sections 114-2684, 114-2943, 114-3444, 114-3452, 114-3466, 114-3468, 114-3792, and 114-3926, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the
City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, is hereby amended by repealing Sections 114-2684, 114-2943, 114-3444, 114-3452, 114-3466, 114-3468, 114-3792, and 114-3926 thereof and enacting new Sections 114-2684, 114-2943, 114-3444, 114-3452, 114-3466, 114-3468, 114-3792, and 114-3926, relating to traffic and vehicle regulations, as follows:

**Sec. 114-2684. Southeast Eighth Street--East
Vine Street to Hart Avenue.**

Southeast Eighth Street, on the west side,
from East Vine Street to a point 250 feet
south of East Railroad Avenue, no parking
any time.

Southeast Eighth Street, on the west side,
from Van Buren Avenue to East Edison Avenue,
no parking any time.

Southeast Eighth Street, on the east side,
from Hartford Avenue to a point 100 feet
south of East Indianola Avenue, no parking
any time.

Southeast Eighth Street, on the west side,
from Lacona Avenue to a point 65 feet south
thereof, no parking any time.

Southeast Eighth Street, on the west side,
from East Bell Avenue to a point 80 feet
north thereof, no parking any time.

Southeast Eighth Street, on the west side, from a point 600 feet south of East Bell Avenue to a point 100 feet south thereof, no parking any time.

Southeast Eighth Street, on the west side, from Indianola Avenue to East Emma Avenue, no parking any time.

Southeast Eighth Street, on the east side, from East Watrous Avenue to a point 50 feet north thereof, no parking any time.

Southeast Eighth Street, on the west side, from East Spring Street to East Kenyon Avenue, no parking any time.

Southeast Eighth Street, on the east side, from East Porter Avenue to East Diehl Avenue, no parking any time.

Southeast Eighth Street, on the east side, from East Porter Avenue to a point 60 feet south thereof, no stopping, no standing, 7:00 a.m. to 5:00 p.m. school days.

Southeast Eighth Street, on the west side, from East Diehl Avenue to Hart Avenue, no parking any time.

Sec. 114-2943. Fifty-first Street--Welker Avenue to Aurora Avenue.

Fifty-first Street, on the east side, from Welker Avenue to Grand Avenue, no parking any time.

Fifty-first Street, on the west side, from a point 60 feet south of Robertson Drive to a point 60 feet north of Robertson Drive, no parking any time.

Fifty-first Street, on the west side, from a point 670 feet south of Grand Avenue to a

point 350 feet south thereof, no parking any time.

Fifty-first Street, on the west side, from Grand Avenue to a point 60 feet south thereof, no parking any time.

Fifty-first Street, on the west side, from Harwood Drive to Pleasant Street, no parking any time.

Fifty-first Street, on the west side, from Franklin Avenue to Allison Avenue, no parking any time.

Fifty-first Street, on the west side, from Lincoln Avenue to Hickman Road, no parking any time.

Fifty-first Street, on the east side, from Hickman Road to Urbandale Avenue, no parking any time.

Fifty-first Street, on the west side, from Hickman Road to 120 feet north thereof, no parking any time.

Fifty-first Street, on the west side, from Douglas Avenue to Aurora Avenue, no parking any time.

Fifty-first Street, on the east side, from Douglas Avenue to a point 50 feet north thereof, no parking any time.

Fifty-first Street, on the east side, from Madison Avenue to a point 50 feet south thereof, no parking any time.

Fifty-first Street, on the east side, from Madison Avenue to a point 50 feet north thereof, no parking any time.

Fifty-first Street, on the east side, from Aurora Avenue to Twana Drive, no parking any time.

Fifty-first Street, on the east side, from Aurora Avenue to a point 50 feet south thereof, no parking any time.

Fifty-first Street, on the west side, from Bel-Aire Road to Crestmoor Place, no parking any time.

Sec. 114-3444. Lynn Street--Sixteenth Street to Keosauqua Way.

Lynn Street, on the south side, from Sixteenth Street to Keosauqua Way, no parking any time.

Lynn Street, on the north side, from Sixteenth Street to a point 50 feet west thereof, no parking any time.

Sec. 114-3452. Mahaska Avenue--East Twenty-ninth Street to Williams Street.

Mahaska Avenue, on the north side, from East Twenty-ninth Street to East Thirty-third Street, no parking any time.

Mahaska Avenue, on the south side, from East Thirty-third Street to a point 50 feet west thereof, no parking any time.

Mahaska Avenue, on the north side, from East Thirty-third Street to a point 50 feet east thereof, no parking any time.

Mahaska Avenue, on the south side, from East Thirty-third Street to East Thirty-fourth Street, no parking any time.

Mahaska Avenue, on the north side, from East Thirty-fourth Street to a point 50 feet west, no parking any time.

Mahaska Avenue, on the south side, from East Thirty-seventh Court to Williams Street, no parking any time.

Sec. 114-3466. Market Street--Southwest First Street to Southwest Sixth Street.

Market Street, on the south side, from a point 135 feet west of Southwest First Street to a point forty feet west thereof, loading zone.

Market Street, on the north side, from Southwest First Street to Southwest Third Street, no parking 7:00 a.m. to 6:00 p.m., Monday through Friday.

Market Street, on both sides, from Southwest Fourth Street to Southwest Sixth Street, no parking any time.

Sec. 114-3468. East Market Street--Des Moines River to Southeast Twenty-ninth Court.

East Market Street, on the south side, from Southeast Third Street to a point 50 feet west of Southeast Fourth Street, no parking 7:00 a.m. to 6:00 p.m., Monday through Friday.

East Market Street, on the south side, from Southeast Fourth Street to a point 50 feet west thereof, no parking any time.

East Market Street, on both sides, from Southeast Sixth Street to Southeast Eighth Street, no parking any time.

East Market Street, on the north side, from Southeast Eighteenth Street to Southeast Twentieth Street, no parking any time.

East Market Street, on both sides, from Southeast Twentieth Street to Southeast Twenty-fifth Court, no parking any time.

East Market Street, on the north side, from Southeast Twenty-fifth Court to Southeast Twenty-ninth Court, no parking any time.

East Market Street, on the south side, from Southeast Twenty-seventh Street to a point 100 feet east thereof, no parking any time.

Sec. 114-3792. Woodland Avenue--Twenty-eighth Street to Thirty-fifth Street.

Woodland Avenue, on the south side, from Twenty-ninth Street to a point 125 feet west thereof, no parking any time.

Woodland Avenue, on the south side, from a point 75 feet east of Thirty-first Street to Thirty-fifth Street, no parking any time.

Woodland Avenue, on the north side, from Twenty-eighth Street to a point 75 feet west of Thirty-first Street, no parking any time.

Woodland Avenue, on the north side, from Thirty-fifth Street, to a point 75 feet east thereof, no parking any time.

Sec. 114-3926. Market Street--Southwest First Street to Southwest Fourth Street.

Market Street, on the south side, from Southwest First Street to a point 135 feet west thereof, ten-hour meters, 8:00 a.m. to 6:00 p.m.

Sec. 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
