

ORDINANCE NO. 13,907

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, by repealing Sections 114-661 and 114-663 thereof and enacting new Sections 114-661 and 114-663, relating to rates for parking garages.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, is hereby amended by repealing Sections 114-661 and 114-663 thereof and enacting new Sections 114-661 and 114-663, relating to rates for parking garages, as follows:

**Sec. 114-661. Rates for Seventh and Grand Parking Garage.**

Subject to section 114-666 of this division, the following rates shall be charged at the Seventh and Grand Parking Garage:

**Sec, 114-663. Rates for Fourth and Grand Parking Garage.**

Subject to section 114-666 of this subchapter, the following rates shall be charged at the Fourth and Grand Parking Garage:

First Hour \$ .60 per hour

Second Hour \$ .60 per hour

Each Additional Hour \$ .75 per hour

12 Hour Maximum \$ 5.00

24 Hour Maximum \$ 7.00

Monthly Floater \$80.00

Monthly Reserved \$88.00

Monthly – Elsie Mason Manor

Residents \$50.00

Monthly Reserved \$55.00

Monthly 4:00 p.m.

until 6:00 a.m. \$40.00

Prepaid Special Events \$ 2.00
