

ORDINANCE NO. 14,015

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, by repealing Sections 114-1269, 114-2830, 114-2845, 114-3461 and 114-3574 thereof and enacting new Sections 114-1269, 114-2830, 114-2845, 114-3461 and 114-3574, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, is hereby amended by repealing Sections 114-1269, 114-2830, 114-2845, 114-3461 and 114-3574 thereof and enacting new Sections 114-1269, 114-2830, 114-2845, 114-3461 and 114-3574, relating to traffic and vehicle regulations, as follows:

Sec. 114-1269. Southeast Thirty-fourth Street.

Southeast Thirty-fourth Street, from East Watrous Avenue to Evergreen Avenue, 30 miles per hour.

Southeast Thirty-fourth Street, from Evergreen Avenue to Easter Lake Drive, 35 miles per hour.

Sec. 114-2830. East Twenty-fifth Street--Dean Avenue to East Aurora Avenue.

East Twenty-fifth Street, on the east side, from Dean Avenue to Easton Boulevard, no parking any time.

East Twenty-fifth Street, on the west side, from a point 170 feet south of Walnut Street to a point 50 feet north of Walnut Street, no parking any time.

East Twenty-fifth Street, on the west side, from Maple Avenue to a point 50 feet north thereof, no parking any time.

East Twenty-fifth Street, on the west side, from East University Avenue to a point 50 feet south thereof, no parking any time.

East Twenty-fifth Street, on the west side, from East University Avenue to a point 75 feet north thereof, no parking any time.

East Twenty-fifth Street, on the west side, from Garfield Avenue to a point 150 feet north thereof, no parking any time.

East Twenty-fifth Street, on the west side, from East Jefferson Avenue to Guthrie Avenue, no parking any time.

East Twenty-fifth Street, on the east side, from Guthrie Avenue to a point 120 feet north thereof, no parking any time.

East Twenty-fifth Street, on the east side, from Wedgewood Road to East Euclid Avenue, no parking any time.

East Twenty-fifth Street, on the west side, from Guthrie Avenue to East Euclid Avenue, no parking any time.

East Twenty-fifth Street, on the east side, from East Sheridan Avenue to a point 50 feet north thereof, no parking any time.

East Twenty-fifth Street, on the east side, from a point 120 feet north of Guthrie Avenue to East Sheridan Avenue, no parking 7:00 a.m. to 6:00 p.m., Monday through Friday.

East Twenty-fifth Street, on the east side, from a point 50 feet north of East Sheridan Avenue to Wedgewood Road, no parking 7:00 a.m. to 6:00 p.m., Monday through Friday.

East Twenty-fifth Street, on the east side, from East Douglas Avenue to East Aurora Avenue, no parking any time.

East Twenty-fifth Street, on the west side, from East Shawnee Avenue to East Aurora Avenue, no parking any time.

**Sec. 114-2845. East Twenty-seventh Street--
Dean Avenue to East Aurora Avenue.**

East Twenty-seventh Street, on the east side, from Dean Avenue to East University Avenue, no parking any time.

East Twenty-seventh Street, on the east side, from a point 50 feet north of Capitol Avenue to a point 50 feet south of Capitol Avenue, no parking any time.

East Twenty-seventh Street, on the east side, from a point 50 feet north of East Grand Avenue to a point 50 feet south of East Grand Avenue, no parking any time.

East Twenty-seventh Street, on the east side, from East University Avenue to a point 50 feet north thereof, no parking any time.

East Twenty-seventh Street, on the west side, from East University Avenue to a point 75 feet north thereof, no parking any time.

East Twenty-seventh Street, on the east side, from Kinsey Avenue to a point 140 feet south thereof, no parking any time.

East Twenty-seventh Street, on the west side, from a point 75 feet south of East University Avenue to Guthrie Avenue, no parking any time.

East Twenty-seventh Street, on the east side, from Easton Boulevard to a point 125 feet north thereof, no parking any time.

East Twenty-seventh Street, on the east side, from Guthrie Avenue to a point 50 feet south thereof, no parking any time.

East Twenty-seventh Street, on the west side, from Avenue Frederick M. Hubbell to a point 50 feet north thereof, no parking any time.

East Twenty-seventh Street, on the east side, from Avenue Frederick M. Hubbell to Hull Avenue, no parking any time.

East Twenty-seventh Street, on the west side, from Hull Avenue to a point 75 feet south thereof, no parking any time.

East Twenty-seventh Street, on the east side, from East Douglas Avenue to East Aurora Avenue, no parking any time.

East Twenty-seventh Street, on the west side, from East Madison Avenue to a point 60 feet south thereof, no parking any time.

Sec. 114-3461. Maple Street--East First Street to Knob Hill Drive.

Maple Street, on the south side, from East Second Street to East Fourth Street, no parking any time.

Maple Street, on the north side, from a point 166 feet west of East Fourth Street to a point 35 feet west thereof, commercial loading zone.

Maple Street, on the north side, from East Ninth Street to East Twelfth Street, no parking any time.

Maple Street, on the south side, from East Twelfth Street to East Thirteenth Street, no parking any time.

Maple Street, on both sides, from East Fourteenth Street to a point 210 feet east of East Fifteenth Street, no parking any time.

Maple Street, on the south side, from a point 210 feet east of East Fifteenth Street to East Seventeenth Street, no parking any time.

Maple Street, on the north side, from East Seventeenth Street to a point 140 feet east of East Eighteenth Street, no parking any time.

Maple Street, on the south side, from East Eighteenth Street to East Nineteenth Street, no parking any time.

Maple Street, on the south side, from a point 50 feet west of East Twenty-first Street to a point 50 feet east of East Twenty-first Street, no parking any time.

Maple Street, on the north side, from East Twentieth Street to East Twenty-ninth Street, no parking any time.

Maple Street, on the south side, from a point 50 feet east of East Twenty-fifth Street to a point 50 feet west of East Twenty-fifth Street, no parking any time.

Maple Street, on the south side, from a point 50 feet east of East Twenty-seventh Street to a point 50 feet west of East Twenty-seventh Street, no parking any time.

Maple Street, on the south side, from a point 70 feet east of East Twenty-eighth Street to a point 60 feet west of East Twenty-eighth Street, no parking any time.

Maple Street, on the south side, from East Twenty-ninth Street to East Thirtieth Street, no parking any time.

Maple Street, on the north side, from East Thirtieth Street to a point 75 feet west thereof, no parking any time.

Maple Street, on the north side, from Williams Street to Knob Hill Drive, no parking any time.

Maple Street, on the north side, from East Thirty-sixth Court to a point 50 feet east thereof, no parking any time.

Maple Street, on the south side, from East Thirty-sixth Court to a point 250 feet east thereof, no parking any time.

Maple Street, on the north side, from East Fortieth Street to East Forty-first Street, no parking any time.

Sec. 114-3574. Pleasant Street--Ninth Street to Tenth Street.

Pleasant Street, on the north side, from Ninth Street to Tenth Street, no parking 7:00 a.m. to 9:00 a.m.

Pleasant Street, on the south side, from Tenth Street to a point 60 feet east thereof, no parking any time.

Sec. 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
