

ORDINANCE NO. 14,071

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance No. 13,855, passed August 21, 2000, and Ordinance No. 13,994, passed September 10, 2001, and Ordinance 14,025, passed December 3, 2001, and Ordinance 14,038, passed January 7, 2002, by repealing Sections 114-2639, 114-2921, 114-3183, 114-3864, 114-3868, 114-3870, 114-3883, 114-3902, 114-3927, 114-4072, 114-4079, 114-4084, and 114-4110 thereof and enacting new Sections 114-2639, 114-2921, 114-3183, 114-3864, 114-3868, 114-3870, 114-3883, 114-3902, 114-3927, 114-4072, 114-4079, 114-4084, and 114-4110, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the
City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance No. 13,855, passed August 21, 2000, and Ordinance No. 13,994, passed September 10, 2001, and Ordinance 14,025, passed December 3, 2001, and Ordinance 14,038, passed January 7, 2002 is hereby amended by repealing Sections 114-2639, 114-2921, 114-3183, 114-3864, 114-3868, 114-3870, 114-3883, 114-3902, 114-3927, 114-4072, 114-4079, 114-4084, and 114-4110 thereof and enacting new Sections 114-2639, 114-2921, 114-3183, 114-3864, 114-3868, 114-3870, 114-3883, 114-3902, 114-3927, 114-4072, 114-4079, 114-4084, and 114-4110, relating to traffic and vehicle regulations, as follows:

**Sec. 114-2639. Sixth Avenue--Cherry Street
to Mulberry Street.**

Sixth Avenue, on the west side, from Cherry Street to a point 145 feet north thereof, reserved for sheriffs.

Sixth Avenue, on the west side, from a point 145 feet north of Cherry Street to Mulberry Street, no parking 4:00 p.m. to 6:00 p.m.

Sixth Avenue, on the east side, from Cherry Street to a point 135 feet north thereof, reserved parking, marked police vehicles only.

Sec. 114-2921. Forty-first Street--Grand Avenue to north city limits.

Forty-first Street, on the east side, from Grand Avenue to Ingersoll Avenue, no parking any time.

Forty-first Street, on the east side, from Ingersoll Avenue to a point 30 feet north thereof, no parking any time.

Forty-first Street, on the west side, from Ingersoll Avenue to Center Street, no parking any time.

Forty-first Street, on the east side, from University Avenue to Forest Avenue, no parking any time.

Forty-first Street, on the west side, from University Avenue to a point 125 feet north thereof, no parking any time.

Forty-first Street, on the west side, from a point 125 feet north of University Avenue to Forest Avenue, no parking 7:00 a.m. to 6:00 p.m.

Forty-first Street, on the east side, from a point 50 feet south of Northwest Drive to a point 75 feet north of Northwest Drive, no parking any time.

Forty-first Street, on the west side, from Forest Avenue to Beaver Avenue, no parking any time.

Forty-first Street, on the east side, from a point 100 feet south of College Avenue to a point 100 feet north of College Avenue, no parking any time.

Forty-first Street, on the east side, from Germania Drive to a point 85 feet south thereof, no parking any time.

Forty-first Street, on the east side, from Beaver Avenue to Northwest Drive, no parking any time.

Forty-first Street, on the east side, from Douglas Avenue to a point 50 feet north thereof, no parking any time.

Forty-first Street, on the west side, from Douglas Avenue to Shawnee Avenue, no parking any time.

Forty-first Street, on the west side, from Aurora Avenue to a point 730 feet north thereof, no parking any time.

Forty-first Street, on the east side, from Aurora Avenue to a point 50 feet north thereof, no parking any time.

Sec. 114-3183. Enden Lane--Dead end west of Hickory Hill Lane to Winegardner Road.

Enden Lane, on the south side, from a point 135 feet west of Hickory Hill Lane to Winegardner Road, no parking any time.

Enden Lane, on the north side, from Hickory Hill Lane to a point 60 feet east thereof, no parking any time.

Sec. 114-3864. Third Street--Locust Street to Grand Avenue.

Third Street, on the west side, from Locust Street to a point 65 feet north thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

Third Street, on the west side, from a point 85 feet north of Locust Street to a point

145 feet north thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

Third Street, on the east side, 3-406 two-hour meter, 8:00 a.m. to 6:00 p.m., is designated a handicapped parking space and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

Sec. 114-3868. Fourth Street--Grand Avenue to Watson Powell, Jr. Way.

Fourth Street, on the west side, from a point 40 feet north of Grand Avenue to a point 85 feet south of Watson Powell, Jr. Way, two-hour meters, 8:00 a.m. to 6:00 p.m.

Fourth Street, on the west side, from Watson Powell, Jr. Way to a point 50 feet south thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

Fourth Street, on the east side, from Grand Avenue to a point 100 feet north thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

Fourth Street, on the east side, from a point 125 feet north of Grand Avenue to a point 85 feet north thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

Fourth Street, on the east side, from Watson Powell, Jr. Way to a point 60 feet south thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

Fourth Street, on the west side, 4-520 two-hour meter, 8:00 a.m. to 6:00 p.m., is designated a handicapped parking space and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

Sec. 114-3870. Fourth Street--Court Avenue to Walnut Street.

Fourth Street, on the west side, from a point 130 feet north of Court Avenue to a point 70 feet north thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

Fourth Street, on the west side, from a point 180 feet north of Court Avenue to a point 65 feet north thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

Fourth Street, on the east side, from a point 60 feet north of Court Avenue to a point 100 feet north thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

Fourth Street, on the east side, from a point 285 feet north of Court Avenue to Walnut Street, two-hour meters, 8:00 a.m. to 6:00 p.m.

Fourth Street, on the east side, parking meter 4-209, two-hour meter, 8:00 a.m. to 6:00 p.m., is designated a handicapped parking space and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

Sec. 114-3883. Sixth Avenue--Cherry Street to Mulberry Street.

Sixth Avenue, on the east side, parking meter 6-101, 6-103, 6-105, 6-107 and 6-109 four-hour meters, 8:00 a.m. to 6:00 p.m., are designated a handicapped parking spaces and are subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

Sixth Avenue, on the west side, from a point 145 feet north of Cherry Street to Mulberry Street, two-hour meters, 8:00 a.m. to 4:00 p.m.

Sec. 114-3902. Tenth Street--Cherry Street to Mulberry Street.

Tenth Street, on the east side, parking meters 10-103, 10-105, 10-107, 10-108, 10-109 and 10-110, ten-hour meters, 8:00 a.m. to 6:00 p.m. are designated handicapped parking spaces and are subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

Tenth Street, on the west side, from Cherry Street to Mulberry Street, four-hour meters, 8:00 a.m. to 6:00 p.m.

Tenth Street, on the west side, parking meters 10-101, 10-111, 10-113, 10-115 and 10-117, four-hour meters, 8:00 a.m. to 6:00 p.m.

Tenth Street, on the east side, from Cherry Street to a point 100 feet north thereof, four-hour meters, 8:00 a.m. to 6:00 p.m.

Tenth Street, on the east side, from a point 145 feet north of Cherry Street to a point 40 feet south of Mulberry Street, four-hour meters, 8:00 a.m. to 6:00 p.m.

Sec. 114-3927. Mulberry Street--Fifth Avenue to Sixth Avenue.

Mulberry Street, on the north side, from Fifth Avenue to a point 65 feet west thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

Mulberry Street, on the south side, parking meter M-506, two-hour meter, 8:00 a.m. to 6:00 p.m., is designated a handicapped parking space and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

Mulberry Street, on the south side, from a point 55 feet west of Fifth Avenue to a point 50 feet east of Sixth Avenue, two-hour meters, 8:00 a.m. to 6:00 p.m.

Sec. 114-4072. East First Street--Des Moines Street to East River Drive.

East First Street, on the west side, from a point 25 feet north of Des Moines Street to a point 90 feet north thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

East First Street, on the west side, from a point 160 feet north of Des Moines Street to a point 30 feet north thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

Sec. 114-4079. East Second Street--East Court Avenue to East Walnut Street.

East Second Street, on the east side, from a point 30 feet north of East Court Avenue to a point 135 feet north hereof, four-hour meters, 8:00 a.m. to 6:00 p.m.

East Second Street, on the east side, from East Walnut Street to a point 45 feet south thereof, four-hour meters, 8:00 a.m. to 6:00 p.m.

East Second Street, on the east side, from a point 205 feet north of East Court Avenue to a point 70 feet south of East Walnut Street, four-hour meters, 8:00 a.m. to 6:00 p.m.

East Second Street, on the east side, parking meter E2-201, ten-hour meter, 8:00 a.m. to 6:00 p.m., is designated as handicapped parking spaces and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

Sec. 114-4084. East Fifth Street--East Locust Street to East Grand Avenue.

East Fifth Street, on the west side, from East Locust Street to East Grand Avenue, four-hour meters, 8:00 a.m. to 6:00 p.m.

East Fifth Street, on the west side, E5-400 four-hour meter, 8:00 a.m. to 6:00 p.m., is designated a handicapped parking space and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

East Fifth Street, on the east side, from East Locust Street to a point 205 feet south of East Grand Avenue, four-hour meters, 8:00 a.m. to 6:00 p.m.

Sec. 114-4110. East Walnut Street--East First Street to East Second Street.

East Walnut Street, on the south side, from a point 40 feet east of East First Street to a point 140 feet east thereof, four-hour meters, 8:00 a.m. to 6:00 p.m.

East Walnut Street, on the south side, from a point 190 feet east of East First Street to East Second Street, four-hour meters, 8:00 a.m. to 6:00 p.m.

East Walnut Street, on the north side, from East First Street to East Second Street, ten-hour meters, 8:00 a.m. to 6:00 p.m.

Sec. 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
