

ORDINANCE NO. 14,110

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance No. 13,855, passed August 21, 2000, and amended by Ordinance No. 13,994, passed September 10, 2001, by repealing Sections 114-2633, 114-2938, 114-3552, 114-3553, 114-3554, 114-3931, 114-4033, 114-4034 and 114-4035 thereof and enacting new Sections 114-2633, 114-2938, 114-3552, 114-3553, 114-3554, 114-3931, 114-4033, 114-4034 and 114-4035, relating to traffic and vehicles.

Be It Ordained by the City Council of the
City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, is hereby amended by repealing Sections 114-2633, 114-2938, 114-3552, 114-3553, 114-3554, 114-3931, 114-4033, 114-4034 and 114-4035 thereof and enacting new Sections 114-2633, 114-2938, 114-3552, 114-3553, 114-3554, 114-3931, 114-4033, 114-4034 and 114-4035, relating to traffic and vehicles, as follows:

**Sec. 114-2633. Fifth Avenue--Watson Powell,
Jr. Way to School Street.**

Fifth Avenue, on the west side, from Watson Powell, Jr. Way to a point 30 feet north thereof, no parking any time.

Fifth Avenue, on the east side, from a point 120 feet north of Watson Powell, Jr. Way to a point 25 feet north thereof, commercial loading zone.

Fifth Avenue, on the west side, from Park Street to a point 20 feet north thereof, no parking any time.

Fifth Avenue, on the east side, from a point 20 feet north of Park Street to a point 52 feet north thereof, loading zone.

Fifth Avenue, on the east side, from Crocker Street to Center Street, no parking any time.

Fifth Avenue, on the west side, from Crocker Street to a point 290 feet south thereof, no parking any time.

Fifth Avenue, on the west side, from Center Street to a point 50 feet north thereof, no parking any time.

Fifth Avenue, on both sides, from Crocker Street to School Street, no parking any time.

Sec. 114-2938. Forty-eighth Street--Dead end south of Ingersoll Avenue to Twana Drive.

Forty-eighth Street, on the west side, from a point 250 feet south of Ingersoll Avenue to Harwood Drive, no parking any time.

Forty-eighth Street, on the east side, from Waterbury Road to a point 50 feet north thereof, no parking any time.

Forty-eighth Street, on the west side, from University Avenue to a point 75 feet north thereof, no parking any time.

Forty-eighth Street, on the east side, from University Avenue to a point 85 feet north of Hickman Road, no parking any time.

Forty-eighth Street, on the west side, from a point 150 feet north of Franklin Avenue to a point 275 feet north thereof, bus loading and unloading 7:00 a.m. to 5:00 p.m. school days.

Forty-eighth Street, on the west side, from Franklin Avenue to a point 200 feet south thereof, no parking any time.

Forty-eighth Street, on the west side, from Hickman Road to a point 60 feet south thereof, no parking any time.

Forty-eighth Street, on the west side, from a point 335 feet south of Hickman Road to a

point 120 feet south thereof, no parking any time.

Forty-eighth Street, on the west side, from a point 650 feet south of Hickman Road to a point 130 feet south thereof, no parking any time.

Forty-eighth Street, on the west side, from Hickman Road to Euclid Avenue, no parking any time.

Forty-eighth Street, on the east side, from Urbandale Avenue to a point 75 feet north thereof, no parking any time.

Forty-eighth Street, on the west side, from Seneca Avenue to Madison Avenue, no parking any time.

Forty-eighth Street, on the east side, from a point 50 feet north of Aurora Avenue to Merced Street, no parking 8:00 a.m. to 5:00 p.m. school days.

Forty-eighth Street, on the west side, from Aurora Avenue to Twana Drive, no parking any time.

Forty-eighth Street, on the east side, from Aurora Avenue to a point 50 feet north thereof, no parking any time.

Sec. 114-3552. Park Street--Second Avenue to Fourth Street.

Park Street, on the north side, from Third Street to Fourth Street, no parking any time.

Park Street, on the south side, from Fourth Street to a point 30 feet east thereof, no parking any time.

Sec. 114-3553. Park Street--Fourth Street to Fifth Avenue.

Park Street, on the north side, from Fourth Street to Fifth Avenue, no parking any time.

Park Street, on the south side, from Fourth Street to a point 60 feet west thereof, no parking any time.

Sec. 114-3554. Park Street--Fifth Avenue to Sixth Avenue.

Park Street, on the north side, from Fifth Avenue to Sixth Avenue, no parking any time.

Sec. 114-3931. Pleasant Street--Ninth Street to Tenth Street.

Pleasant Street, on the north side, from Ninth Street to Tenth Street, four-hour meters, 9:00 a.m. to 6:00 p.m.

Pleasant Street, on the south side, from Ninth Street to a point 60 feet east of Tenth Street, four-hour meters, 8:00 a.m. to 6:00 p.m.

Sec. 114-4033. Park Street--Second Avenue to Fourth Street.

Park Street, on the south side, from Second Avenue to Third Street, ten-hour meters, 8:00 a.m. to 6:00 p.m.

Park Street, on the north side, from Second Avenue to Third Street, ten-hour meters, 8:00 a.m. to 6:00 p.m.

Park Street, on the south side, from Third Street to a point 30 feet east of Fourth

Street, ten-hour meters, 9:00 a.m. to 6:00 p.m.

Sec. 114-4034. Park Street--Fourth Street to Fifth Avenue.

Park Street, on the south side, from a point 60 feet west of Fourth Street to Fifth Avenue, ten-hour meters, 9:00 a.m. to 6:00 p.m.

Sec. 114-4035. Park Street--Fifth Avenue to Sixth Avenue.

Park Street, on the south side, from Fifth Avenue to Sixth Avenue, ten hour meters, 9:00 a.m. to 6:00 p.m.

Sec. 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
