A suitable mechanical signal device, as defined in section 114-81 of this article, and short arm gates constructed according to the specifications and standards of the state department of transportation shall be erected, maintained and operated by the Union Pacific Railroad Company at the intersection of its tracks located on Evergreen Avenue between Southeast Fortieth Street and Southeast Forty-fifth Street.
