

ORDINANCE NO. 14,918

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance No. 14,038 passed January 7, 2002 by amending Sections 114-2253, 114-2277 and 114-2944, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance No. 14,038 passed January 7, 2002 by amending Sections 114-2253, 114-2277 and 114-2944, relating to traffic and vehicle regulations, as follows:

**Sec. 114-2253. King Avenue.**

King Avenue, at Southeast Nineteenth Street, stop.  
King Avenue, at Creston Avenue/Southeast Twentieth Street, stop.

**Sec. 114-2277. East Madison Avenue.**

East Madison Avenue, from the west line of First Street to the west line of McDonald Street, stop.  
East Madison Avenue, at East Twenty-third Street (south approach), stop.  
East Madison Avenue, from the east line of East Twenty-fifth Street to the west line of East Twenty-ninth Street, stop.  
East Madison Avenue, at East Thirtieth Street, stop.

**Sec. 114-2944. Fifty-second Street--Robertson Drive to Aurora Avenue.**

Fifty-second Street, on the west side, from Robertson Drive to a point 120 feet north thereof, no parking any time.  
Fifty-second Street, on the east side, from Robertson Drive to a point 720 feet north thereof, no parking any time.  
Fifty-second Street, on the west side, from Woodland Avenue to Pleasant Street, no parking any time.  
Fifty-second Street, on the east side, from Franklin Avenue to

Hickman Road, no parking any time.

Fifty-second Street, on the west side, from Hickman Road to a point 50 feet south thereof, no parking any time.

Fifty-second Street, on the east side, from Urbandale Avenue to a point 50 feet north thereof, no parking any time.

Fifty-second Street, on the west side, from Urbandale Avenue to Aurora Avenue, no parking any time.

Fifty-second Street, on the east side, from Douglas Avenue to a point 75 feet south thereof, no parking any time.

Fifty-second Street, on the east side, from Douglas Avenue to a point 50 feet north thereof, no parking any time.

Fifty-second Street, on the east side, from Madison Avenue to a point 50 feet north thereof, no parking any time.

Fifty-second Street, on the east side, from Aurora Avenue to a point 50 feet south thereof, no parking any time.

Sec. 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
