

ORDINANCE NO. 15,041

AN ORDINANCE to amend the Official Zoning Map of the City of Des Moines, Iowa, set forth in Section 134-277 of the Municipal Code of the City of Des Moines, Iowa, 2000, by rezoning and changing the district classification of certain property located in the vicinity of 201 S.E. 29th Court from the M-1 Light Industrial to Limited R1-60 One-Family Low-Density Residential District classification.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Official Zoning Map of the City of Des Moines, Iowa, set forth in Section 134-277 of the Municipal Code of the City of Des Moines, Iowa, 2000, be and the same is hereby amended by rezoning and changing the district classification of certain property located in the vicinity of 201 S.E. 29th Court, more fully described as follows, from the M-1 Light Industrial to Limited R1-60 One-Family Low-Density Residential District classification:

Lots 15 and 16, R A Wests Subdivision, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa

Section 2. That this ordinance and the zoning granted by the terms hereof are subject to the following imposed additional conditions which have been agreed to and accepted by execution of an Acceptance of Rezoning Ordinance by all owners of said property and are binding upon the owners and their successors, heirs, and assigns as follows:

- a. Any new dwelling or addition to the existing dwelling on the subject property shall be kept at least 25 feet from the west property line.
- b. Any new single-family dwelling constructed shall meet the following design requirements:
 - (1) Have a minimum of 1,200 square feet of living area exclusive of any attached garage.
 - (2) Have an attached or detached garage for parking of at least two vehicles.

- (3) Have either an open roofed front porch or shall have at least 40% of the front façade comprised of brick, stone or block masonry material.
- (4) All exterior siding material shall be masonry, stone, cement board or minimum 42 mil thickness vinyl.
- (5) All exterior roofing material shall be architectural asphalt shingles.

Section 3. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.

Section 4. The City Clerk is hereby authorized and directed to cause a certified copy of the Acceptance of Rezoning Ordinance, this ordinance, a vicinity map, and proof of publication of this ordinance, to be properly filed in the office of the Polk County Recorder.
