

ORDINANCE NO. 15,253

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-2104, 114-2181, 114-2655, 114-3261 and 114-4086, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-2104, 114-2181, 114-2655, 114-3261 and 114-4086, relating to traffic and vehicle regulations, as follows:

Sec. 114-2104. Thirty-eighth Street.

Thirty-eighth Street, at Crocker Street, stop.
Thirty-eighth Street, at Washington Avenue, stop.
Thirty-eighth Street, at Holcomb Avenue, stop.
Thirty-eighth Street, at Amick Avenue, stop.
Thirty-eighth Street, at Valdez Drive, stop.
Thirty-eighth Street, at Bel-Aire Road, stop.

Sec. 114-2181. Crocker Street.

Crocker Street, from the west line of Seventh Street to the east line of Ninth Street, stop.
Crocker Street, from the west line of Ninth Street to the east line of Twelfth Street, stop.
Crocker Street, from the east line of Sixteenth Street to the east line of Nineteenth Street, stop.
Crocker Street, from the west line of Thirty-first Street to the east line of Thirty-fifth Street, stop.
Crocker Street, from the west line of Thirty-fifth Street to the east line of Thirty-eighth Street, stop.
Crocker Street, from the west line of Thirty-eighth Street to the east line of Forty-second Street, stop.

Sec. 114-2655. East Sixth Street--East Grand Avenue to Des Moines Street.

East Sixth Street, on the west side, from East Grand Avenue to a point 50 feet north thereof, no parking any time.

East Sixth Street, on the west side, from a point 50 feet north of East Grand Avenue to a point 115 feet north thereof, no parking 7:00 a.m. to 9:00 a.m., weekdays.

East Sixth Street, on the west side, from a point 50 feet north of East Grand Avenue to a point 60 feet north thereof, commercial loading zone, no parking 7:00 a.m. to 9:00 a.m., weekdays.

East Sixth Street, on the east side, from a point 60 feet north of East Grand Avenue to a point 50 feet north thereof, commercial loading zone.

Sec. 114-3261. Grand Avenue--Nineteenth Street to Twenty-eighth Street.

Grand Avenue, on the north side, from Nineteenth Street to Twenty-eighth Street, no parking any time.

Grand Avenue, on the south side, from Nineteenth Street to 420 feet west thereof, school bus loading zone.

Grand Avenue, on the south side, from a point 420 feet west of Nineteenth Street to Twenty-eighth Street, no parking any time.

Grand Avenue, on the north side, from a point 830 feet west of Nineteenth Street to a point 120 feet west thereof, in the paved border area parking inset only, is designated a handicapped parking area and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

Sec. 114-4086. East Sixth Street--East Grand Avenue to Des Moines Street.

East Sixth Street, on the west side, from a point 50 feet north of East Grand Avenue to a point 115 feet north thereof, four-hour meters, 9:00 a.m. to 6:00 p.m.

East Sixth Street, on the west side, from a point 165 feet north of East Grand Avenue to Des Moines Street, four-hour meters, 8:00 a.m. to 6:00 p.m.

East Sixth Street, on the east side, from East Grand Avenue to a point 60 feet north thereof, four-hour meters, 8:00 a.m. to 6:00 p.m.

East Sixth Street, on the east side, from a point 110 feet north of East Grand Avenue Des Moines Street, four-hour meters, 8:00 a.m. to 6:00 p.m.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
