

ORDINANCE NO. 15,306

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2641, 114-3261 and 114-3881, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-2641, 114-3261 and 114-3881, relating to traffic and vehicle regulations, as follows:

**Sec. 114-2641. Sixth Avenue--Walnut Street to Locust Street.**

Sixth Avenue, on the east side, from Walnut Street to a point 135 feet north thereof, no parking 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m. Monday through Friday.

Sixth Avenue, on the east side, from a point 135 feet north of Walnut Street to Locust Street, no parking 7:00 a.m. to 6:00 p.m. Monday through Friday.

Sixth Avenue, on the west side, from a point 70 feet north of Walnut Street to a point 40 feet north thereof, commercial loading zone.

**Sec. 114-3261. Grand Avenue--Nineteenth Street to Twenty-eighth Street.**

Grand Avenue, on the north side, from Nineteenth Street to Twenty-eighth Street, no parking any time.

Grand Avenue, on the south side, from a point 70 feet west of Eighteenth Street to 420 feet west of Nineteenth Street, school bus loading zone, 7:00 a.m. to 5:00 p.m., school days; no parking at all other times.

Grand Avenue, on the south side, from a point 420 feet west of Nineteenth Street to Twenty-eighth Street, no parking any time.

Grand Avenue, on the north side, from a point 830 feet west of Nineteenth Street to a point 120 feet west thereof, in the paved border area parking inset only, is designated a handicapped parking area and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

**Sec. 114-3881. Sixth Avenue--Walnut Street to Locust Street.**

Sixth Avenue, parking meter 6-301, two-hour meter, 8:00 a.m. to 6:00 p.m., on the east side, is designated as a handicapped meter, and is subject to the same prohibition as is found in subsection 114-616(a) of this Code.

Sixth Avenue, parking meter 6-304, two-hour meter, 8:00 a.m. to 6:00 p.m., on the west side, is designated as a handicapped meter, and is subject to the same prohibition as is found in subsection 114-616(a) of this Code.

Sixth Avenue, on the west side, parking meter 6-312, two-hour meter, 8:00 a.m. to 6:00 p.m., is designated a handicapped parking space and is subject to the same prohibition as is found in section 114-616(a) of this Code.

Sixth Avenue, on the west side, from Walnut Street to a point 70 feet north thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

Sixth Avenue, on the west side, from a point 110 feet north of Walnut Street to a point 22 feet north thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

Sixth Avenue, on the west side, from a point 220 feet north of Walnut Street to Locust Street, two-hour meters, 8:00 a.m. to 6:00 p.m.

Sixth Avenue, on the east side, from Walnut Street to a point 110 feet north thereof, two-hour meters, 9:00 a.m. to 4:00 p.m.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
