

ORDINANCE NO. 15,426

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2598, 114-2635, 114-3269, 114-3270, 114-3415, 114-3778, 114-4083, 114-4084, 114-4098 and 114-4099, and by repealing Sections 114-1852 and 114-4024, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-2598, 114-2635, 114-3269, 114-3270, 114-3415, 114-3778, 114-4083, 114-4084, 114-4098 and 114-4099, and by repealing Sections 114-1852 and 114-4024, relating to traffic and vehicle regulations.as follows:

**Sec. 114-1852. Repealed by Ord. No. 15,426.**

**Sec. 114-2598. East Second Street--East Grand Avenue to Maple Street.**

East Second Street, on the east side, from Des Moines Street to Maple Street, no parking any time.

East Second Street, on the west side, from a point 250 feet north of Des Moines Street to a point 265 feet north thereof, no parking any time.

East Second Street, on the west side, from Des Moines Street to a point 50 feet north thereof, no parking any time.

**Sec. 114-2635. East Fifth Street--East Walnut Street to Lyon Street.**

East Fifth Street, on the east side, from East Locust Street to a point 60 feet south thereof, commercial loading zone.

East Fifth Street, on the east side, from East Walnut Street to a point 95 feet north thereof, commercial loading zone.

East Fifth Street, on the west side, from East Locust Street to a point 25 feet north thereof, no parking any time.

East Fifth Street, on the west side, from East Grand Avenue to a point 15 feet south thereof, no parking any time.

East Fifth Street, on the east side, from East Grand Avenue to a point 40 feet south thereof, no parking any time.

East Fifth Street, on the east side, from a point 95 feet north of East Locust Street to a point 45 feet north thereof, loading zone.

East Fifth Street, on the east side, from East Locust Street to a point 25 feet north thereof, no parking any time.

East Fifth Street, on the west side, from East Grand Avenue to a point 50 feet north thereof, no parking any time.

East Fifth Street, on the west side, from a point 100 feet north of East Grand Avenue to a point 30 feet north thereof, loading zone.

East Fifth Street, on the west side, from a point 75 feet south of Des Moines Street to a point 25 feet south thereof, no parking any time.

East Fifth Street, on the east side, from Des Moines Street to a point 50 feet south thereof, no parking any time.

East Fifth Street, on the east side, from a point 50 feet south of Des Moines Street to a point 50 feet south thereof, passenger loading and unloading.

East Fifth Street, on both sides, from Des Moines Street to a point 50 feet north thereof, no parking any time.

East Fifth Street, on the west side, from Lyon Street to a point 175 feet south thereof, no parking any time.

East Fifth Street, on the east side, from Lyon Street to a point 50 feet south thereof, no parking any time.

#### **Sec. 114-3269. East Grand Avenue--East Fourth Street to East Fifth Street.**

East Grand Avenue, on the north side, from East Fifth Street to a point 90 feet west thereof, no parking any time.

East Grand Avenue, on the south side, from a point 360 feet east of East Fourth Street to a point 25 feet east thereof, no parking any time.

East Grand Avenue, on the south side, from a point 305 feet east of East Fourth Street to a point 15 feet west thereof, no parking any time.

East Grand Avenue, on the north side, from a point 245 feet east of East Fourth Street to a point 50 feet east thereof, commercial loading zone.

East Grand Avenue, on the south side, from a point 80 feet east of East Fourth Street to a point 175 feet east thereof, no parking any time.

East Grand Avenue, on the south side, from East Fourth Street to a point 20 feet east thereof, no parking any time.

East Grand Avenue, on the north side, from East Fourth Street to a point 25 feet east thereof, no parking any time.

East Grand Avenue, on the south side, from East Fifth Street to a point 25 feet west thereof, no parking any time.

#### **Sec. 114-3270. East Grand Avenue--East Fifth Street to East Sixth Street.**

East Grand Avenue, on the south side, from East Fifth Street to a point 25 feet east thereof, no parking any time.

East Grand Avenue, on the south side, from a point 160 feet east of East Fifth Street to a point 100 feet east thereof, commercial loading zone.

East Grand Avenue, on the north side, from East Fifth Street to a point 70 feet east thereof, no parking any time.

East Grand Avenue, on the north side, from a point 70 feet east of East Fifth Street to a point 35 feet east thereof, commercial loading zone.

**Sec. 114-3415. Linden Street--Fifteenth Street to Twenty-eighth Street.**

Linden Street, on the south side, from Fifteenth Street to Sixteenth Street, two-hour parking 9:00 a.m. to 4:00 p.m.

Linden Street, on the north side, from Fifteenth Street to a point 80 feet east of Sixteenth Street, two-hour parking 9:00 a.m. to 4:00 p.m.

Linden Street, on the north side, from a point 50 feet east of Sixteenth Street to a point 30 feet east thereof, commercial loading zone.

Linden Street, on the north side, from a point 50 feet east of Sixteenth Street to Seventeenth Street, two-hour parking 9:00 a.m. to 4:00 p.m.

Linden Street, on the south side, from Sixteenth Street to Seventeenth Street, no parking any time.

Linden Street, on the south side, from Twenty-eighth Street to a point 447 feet east thereof, no parking any time.

Linden Street, on the north side, from Twenty-eighth Street to a point 80 feet east thereof, no parking any time.

**Sec. 114-3778. Willowmere Drive--Dead end north of Park Plaza Drive to Southwest Sixty-third Street.**

Willowmere Drive, on the south side, from a point 280 feet north of Park Plaza and any part of the cul-de-sac to Southwest Twenty-third Street, no parking any time.

Willowmere Drive, on the north side, from a point 50 feet east of Fleur Drive to a point 50 feet west of Fleur Drive, no parking any time.

Willowmere Drive, on the north side, from Southwest Twenty-ninth Street to Southwest Thirtieth Street, no parking any time.

Willowmere Drive, on the south side, from a point 315 feet west of Southwest Sixty-first Street to a point 150 feet west thereof, no parking 8:00 a.m. to 5:00 p.m. Monday through Friday.

Willowmere Drive, on the north side, from a point 425 feet west of Southwest Sixty-first Street to a point 100 feet west thereof, no parking 8:00 a.m. to 5:00 p.m., Monday through Friday.

Willowmere Drive, on both sides, from Southwest Sixty-third Street to a point 50 feet east thereof, no parking any time.

**Sec. 114-4024. Repealed by Ord. No. 15,426.**

**Sec. 114-4083. East Fifth Street--East Grand Avenue to Des Moines Street.**

East Fifth Street, on the west side, from a point 50 feet north of East Grand Avenue to a point 50 feet north thereof, ten-hour meters, 8:00 a.m. to 6:00 p.m.

East Fifth Street, on the west side, from a point 130 feet north of East Grand Avenue to a point 100 feet south of Des Moines Street, ten-hour meters, 8:00 a.m. to 6:00 p.m.

East Fifth Street, on the east side, from East Grand Avenue to a point 145 feet south of Des Moines Street, ten-hour meters, 8:00 a.m. to 6:00 p.m.

East Fifth Street, on the west side, from Des Moines Street to a point 75 feet south thereof, ten-hour meters, 8:00 a.m. to 6:00 p.m.

East Fifth Street, on the east side, E5-511 ten-hour meter, 8:00 a.m. to 6:00 p.m., is designated a handicapped parking meter and is subject to the same prohibition as is found in section 114-616(a) of this chapter.

**Sec. 114-4084. East Fifth Street--East Locust Street to East Grand Avenue.**

East Fifth Street, on the west side, from a point 25 feet north of East Locust Street to East Grand Avenue, four-hour meters, 8:00 a.m. to 6:00 p.m.

East Fifth Street, on the west side, E5-400 and E5-418 four-hour meters, 8:00 a.m. to 6:00 p.m., are designated a handicapped parking meters and are subject to the same prohibition as are found in section 114-616(a) of this chapter.

East Fifth Street, on the east side, from a point 25 feet north of East Locust Street to a point 70 feet north thereof, four-hour meters, 8:00 a.m. to 6:00 p.m.

East Fifth Street, on the east side, from a point 40 feet south of East Grand Avenue to a point 100 feet south thereof, four-hour meters, 8:00 a.m. to 6:00 p.m.

**Sec. 114-4098. East Grand Avenue--East Fourth Street to East Fifth Street.**

East Grand Avenue, on the north side, from a point 25 feet east of East Fourth Street to a point 215 feet east thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

East Grand Avenue, on the south side, from a point 25 feet west of East Fifth Street to a point 85 feet west thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

**Sec. 114-4099. East Grand Avenue--East Fifth Street to East Sixth Street.**

East Grand Avenue, on the north side, from a point 105 feet east of East Fifth Street East Sixth Street, two-hour meters, 8:00 a.m. to 6:00 p.m.

East Grand Avenue, on the south side, from a point 25 feet east of East Fifth Street to a point 135 feet east thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

East Grand Avenue, on the south side, from East Sixth Street to a point 70 feet west thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
