

ORDINANCE NO. 15,464

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by repealing subsection (a) of Section 102-319 thereof, and enacting a new subsection (a) of Section 102-319 thereof, regarding the boundaries of the Skywalk District, and by replacing the Skywalk System Plan Map adopted by reference in subsection (b) of Section 102-319, with the Skywalk System Plan Map dated April 1, 2016.

BE IT ORDAINED by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as amended by Ordinance No. 13,970 passed July 23, 2001, as amended by Ordinance Nos. 14,564 and 14,565 passed May 8, 2006, as amended by Ordinance No. 15,006 passed March 28, 2011, be and is hereby amended by repealing subsection (a) of Section 102-319 thereof, and enacting a new subsection (a) of Section 102-319, regarding the boundaries of the Skywalk District as follows:

Sec. 102-319. Skywalk district and skywalk map.

- (a) The skywalk district is the area enclosed by the following described boundary: The west bank of the Des Moines River from the north line of Grand Avenue to the south line of Court Avenue; the south line of Court Avenue from the west bank of the Des Moines River to the west line of Fifth Avenue; the west line of Fifth Avenue from the south line of Court Avenue to the north line of Cherry Street; the north line of Cherry Street from the west line of Fifth Avenue to the west line of Thirteenth Street; the west line of Thirteenth Street from the north line of Cherry Street to the north line of Walnut Street; the north line of Walnut Street from the west line of Thirteenth Street to the west line of Sixteenth Street; the west line of Sixteenth Street from the north line of Walnut Street to the south line of Locust Street; the south line of Locust Street from the west line of Sixteenth Street to the east line of vacated Eleventh Street; the east line of vacated Eleventh Street from the south line of Locust Street to the north line of Grand Avenue; the north line of Grand Avenue from the east line of 11th Street to the east line of 12th Street; the east line of 12th Street from the north line of Grand Avenue to the south line of relocated High Street; the south line of relocated High Street from the east line of 12th Street to the west line of 6th Avenue; the west line of 6th Avenue from the south line of High Street to the north line of Center Street; the north line of Center Street from the west line of 6th Avenue to the west line of 7th Street; the west line of 7th Street from the north line of Center Street to the north line of Crocker Street; the north line of Crocker Street from the west line of Seventh Street to the east line of relocated Third Street; the east line of

relocated Third Street from the north line of Crocker Street to the north line of Watson Powell, Jr. Way; the north line of Watson Powell, Jr. Way from the east line of Third Street to the east line of Second Avenue; the east line of Second Avenue from the north line of Watson Powell, Jr. Way to the north line of Grand Avenue; and the north line of Grand Avenue from the east line of Second Avenue to the west bank of the Des Moines River.

Sec. 2. That the official Skywalk System Plan Map adopted by reference in subsection (b) of Section 102-319, of the Municipal Code of the City of Des Moines, Iowa, 2000, be and the same is hereby amended by replacing the existing official Skywalk System Plan Map with the new Skywalk System Plan Map dated April 1, 2015.

Sec. 3. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
