

ORDINANCE NO. 15,490

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2924 and 114-3756, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-2924 and 114-3756, relating to traffic and vehicle regulations, as follows:

Sec. 114-2924. East Forty-second Street to East Aurora Avenue.

East Forty-second Street, on the west side, from Boyd Street to a point 100 feet south, no parking any time.

East Forty-second Street, on the west side, from East Sheridan Avenue to a point 50 feet north thereof, no parking any time.

East Forty-second Street, on the west side, from a point 50 feet north of East Sheridan Avenue to a point 740 feet north thereof, passenger loading and unloading 7:00 a.m. to 5:00 p.m. school days.

East Forty-second Street, on the west side, from a point 790 feet north of East Sheridan Avenue to a point 225 feet north thereof, no stopping or standing.

East Forty-second Street, on the west side, from a point 1,015 feet north of East Sheridan Avenue to a point 310 feet north thereof, passenger loading and unloading 7:00 a.m. to 5:00 p.m. school days.

East Forty-second Street, on the west side, from Williams Street to Easton Boulevard, no parking any time.

East Forty-second Street, on the east side, from Easton Boulevard to the north city limits, no parking any time.

East Forty-second Street, on the west side, from a point 85 feet south of Avenue Frederick M. Hubbell to a point 35 feet north of Avenue Frederick M. Hubbell, no parking any time.

East Forty-second Street, on the west side, from Hull Avenue to East Ovid Avenue, no parking 7:00 a.m. to 5:00 p.m.

East Forty-second Street, on the east side, from Wilson Avenue to a point 50 feet north thereof, no parking any time.

Sec. 114-3756. East Washington Avenue--Dead end west of Pennsylvania Avenue to the dead end of East Thirty-third Street.

East Washington Avenue, on the north side, from East Ninth Street to a point 75 feet west thereof, no parking any time.

East Washington Avenue, on the north side, from Pennsylvania Avenue to a point 430 feet west thereof, and any part of the cul-de-sac, no parking any time.

East Washington Avenue, on the south side, from Pennsylvania Avenue to a point 150 feet east of East Fourteenth Street, no parking any time.

East Washington Avenue, on the north side, from East Fourteenth Street to a point 75 feet west thereof, no parking any time.

East Washington Avenue, on the north side, from East Fourteenth Street to East Seventeenth Court, no parking any time.

East Washington Avenue, on the south side, from Sampson Street to East Seventeenth Street, no parking any time.

East Washington Avenue, on the north side, from Delaware Avenue to Tichenor Street, no parking any time.

East Washington Avenue, on the north side, from a point 140 feet west of East Twenty-second Street to Lay Street, no parking any time.

East Washington Avenue, on the north side, from a point 260 feet west of East Twenty-seventh Street to East Twenty-ninth Street, no parking any time.

East Washington Avenue, on the south side, from East Twenty-ninth Street to a point 700 feet east of East Thirty-third Street and on any part of the cul-de-sac, no parking any time.

East Washington Avenue, on the north side, from East Thirty-third Street east for a distance of 160 feet, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
