

ORDINANCE NO. 15,726

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by adding and enacting new Sections 114-3131.5, 114-3602.03, and 114-3629.05, and by amending Sections 114-1639, 114-1690, 114-1731, 114-2358.5, 114-2577, 114-2584, 114-2599, 114-3033.0006, 114-3143, 114-3207, 114-3406, 114-3602.1, 114-3629.1, 114-3708.01, and 114-3782, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by adding and enacting new Sections 114-3131.5, 114-3602.03, and 114-3629.05, and by amending Sections 114-1639, 114-1690, 114-1731, 114-2358.5, 114-2577, 114-2584, 114-2599, 114-3033.0006, 114- 3143, 114-3207, 114-3406, 114-3602.1, 114-3629.1, 114-3708.01, and 114-3782, relating to traffic and vehicle regulations, as follows:

Sec. 114-1639. Thirty-fourth Street.

Thirty-fourth Street, from University Avenue to Hickman Road.

Sec. 114-1690. Guthrie Avenue.

Guthrie Avenue, from East Fourteenth Street to East Twenty-ninth Street.

Sec. 114-1731. Scott Avenue.

Scott Avenue, from Southeast First Street to Southeast Sixth Street.
Scott Avenue, from Southeast Twenty-fifth Court to the east city limits.

Sec. 114-2358.5. Village Run Drive.

Village Run Drive, from the west line of Brook View Drive to the east line of East 52nd Street, stop.
Village Run Drive, at Brook Landing Court, stop.

Sec. 114-2577. Southeast First Court--Parmer Drive to south city limits.

Southeast First Court, on the east side, from Parmer Drive to East Thornton Avenue, no parking any time.

Southeast First Court, on the west side, from Crossroads Drive to the cul-de-sac south and including any part of the cul-de-sac, no parking any time.

Sec. 114-2584. Southeast First Street--East Vine Street to south city limits.

Southeast First Street, on the west side, from East Elm Street to Raccoon Street, no parking any time.

Southeast First Street, on the west side, from East Vine Street to a point 50 feet south thereof, no parking any time.

Southeast First Street, on both sides, from Indianola Avenue to Southwest Water Street, no parking any time.

Southeast First Street, on the east side, from East Hughes Avenue (east leg) to a point 40 feet south thereof, no parking any time.

Southeast First Street, on the west side, from East Hughes Avenue to East Caulder Avenue, no parking any time.

Southeast First Street, on the west side, from East Watrous Avenue to East Leach Avenue, no parking any time.

Southeast First Street, on the east side, from East Leach Avenue to a point 50 feet north thereof, no parking any time.

Southeast First Street, on the east side, from Crossroads Drive to south city limits, no parking any time.

Sec. 114-2599. Southeast Second Street--East Vine Street to south city limits.

Southeast Second Street, on the east side, from Raccoon Street to a point 75 feet north of Raccoon Street, no parking any time.

Southeast Second Street, on the west side, from a point 290 feet north of Raccoon Street to Raccoon Street, no parking any time.

Southeast Second Street, on the west side, from Dean Avenue to Shaw Street, no parking any time.

Southeast Second Street, on the east side, from East Jackson Avenue to East Edison Avenue, no parking any time.

Southeast Second Street, on both sides and at the dead end, from East Edison Avenue to the dead end south, no parking any time.

Southeast Second Street, on the west side, from East Watrous Avenue to East Trowbridge Street, no parking any time.

Southeast Second Street, on the west side, from East Porter Avenue to East Army Post Road, no parking any time.

Southeast Second Street, on the east side, from East Army Post Road to a point 50 feet north thereof, no parking any time.

Southeast Second Street, on the west side, from Crossroads Drive to south city limits, no parking any time.

Sec. 114-3033.0006. Brook Landing Court—Brook View Avenue to east city limits.

Brook Landing Court, on the west side, from Brook View Avenue to the dead end south of Village Run Avenue, no parking any time.

Sec. 114-3131.5. Crossroads Drive—Southeast First Street to Southeast Second Street.

Crossroads Drive, on the south side, from Southeast First Street to Southeast Second Street, no parking any time.

Sec. 114-3143. Dean Avenue--East Eighteenth Street to east city limits.

Dean Avenue, on the south side, from East Eighteenth Street to East Twenty-ninth Court, no parking any time.

Dean Avenue, on the north side, from a point 100 feet west of East Twenty-fourth Street to a point 350 feet east of East Twenty-fourth Street, no parking 7:00 a.m. to 6:00 p.m. Monday through Friday.

Dean Avenue, on the north side, from a point 50 feet east of East Twenty-fifth Street to a point 50 feet west of East Twenty-fifth Street, no parking any time.

Dean Avenue, on the north side, from a point 50 feet east of East Twenty-sixth Street to a point 75 feet west of East Twenty-sixth Street, no parking any time.

Dean Avenue, on the north side, from a point 50 feet east of East Twenty-seventh Street to a point 50 feet west of East Twenty-seventh Street, no parking any time.

Dean Avenue, on the north side, from a point 50 feet east of East Twenty-eighth Street to a point 50 feet west of East Twenty-eighth Street, no parking any time.

Dean Avenue, on the north side, from a point 50 feet east of East Twenty-ninth Street to a point 50 feet west of East Twenty-ninth Street, no parking any time.

Dean Avenue, on the north side, from a point 50 feet east of East Twenty-ninth Street to East Twenty-ninth Court, no parking 7:00 a.m. to 5:00 p.m. school days.

Dean Avenue, on the south side, from East Twenty-ninth Court to a point 50 feet east thereof, no parking any time.

Dean Avenue, on the south side, from a point 50 feet east of East Twenty-ninth Court to a point 175 feet east thereof, school bus loading and unloading.

Dean Avenue, on the south side, from East Thirtieth Street to a point 225 feet east of East Twenty-ninth Court, no parking any time.

Dean Avenue, on the south side, from East Thirtieth Street to the east city limits, no parking any time.

Dean Avenue, on the north side, from East Twenty-ninth Court to a point 640 feet east of East Thirty-second Street, no parking any time.

Dean Avenue, on the north side, from a point 640 feet east of East Thirty-Second Street to a point 330 feet west of East Thirty-fourth Street, passenger loading and unloading.

Dean Avenue, on the north side, from a point 330 feet west of East Thirty-fourth Street to the east city limits, no parking any time.

Sec. 114-3207. Forest Avenue--Thirtieth Street to Sixty-third Street.

Forest Avenue, on the north side, from Thirtieth Street to a point 75 feet west thereof, no parking any time.

Forest Avenue, on the north side, from a point 75 feet west of Thirtieth Street to Thirty-second Street, no parking 7:00 a.m. to 6:00 p.m., Monday through Friday.

Forest Avenue, on the north side, from Thirty-second Street to a point 50 feet west thereof, no parking any time.

Forest Avenue, on the north side, from a point 50 feet west of Thirty-second Street to a point 75 feet east of Thirty-fourth Street, no parking 7:00 a.m. to 6:00 p.m., Monday through Friday.

Forest Avenue, on the north side, from a point 75 feet east of Thirty-fourth Street to Thirty-fourth Street, no parking any time.

Forest Avenue, on the south side, from Thirtieth Street to a point 145 feet west thereof, no parking any time.

Forest Avenue, on the south side, from Thirtieth Street to Thirty-first Street, no parking 7:00 a.m. to 9:00 a.m., Monday through Friday.

Forest Avenue, on the south side, from Thirty-first Street to a point 50 feet east thereof, no parking any time.

Forest Avenue, on the south side, from a point 50 feet east of Thirty-first Street to a point 125 feet west of Thirty-second Street, no parking 7:00 a.m. to 9:00 a.m., Monday through Friday.

Forest Avenue, on the south side, from Thirty-second Street to a point 40 feet east thereof, no parking any time.

Forest Avenue, on the south side, from Thirty-second Street to a point 125 feet west thereof, no parking any time.

Forest Avenue, on the south side, from a point 125 feet west of Thirty-second Street to a point 75 feet east of Thirty-fourth Street, no parking 7:00 a.m. to 9:00 a.m., Monday through Friday.

Forest Avenue, on the south side, from a point 75 feet east of Thirty-fourth Street to a point 225 feet west of Thirty-fourth Street, no parking any time.

Forest Avenue, on the north side, from Thirty-fourth Street to Forty-eighth Street, no parking any time.

Forest Avenue, on both sides, from a point 150 feet east of Randall Place to a point 200 feet west of Randall Place, no parking any time.

Forest Avenue, on the south side, from Thirty-ninth Street to a point 50 feet west thereof, no parking any time.

Forest Avenue, on the south side, from Beaver Avenue to a point 100 feet west thereof, no parking any time.

Forest Avenue, on the south side, from a point 50 feet east of Forty-first Street to a point 100 feet west of Forty-second Street, no parking any time.

Forest Avenue, on the south side, from Forty-sixth Street to a point 75 feet west thereof, no parking any time.

Forest Avenue, on the south side, from Fifty-fifth Street to Merle Hay Road, no parking any time.

Forest Avenue, on the north side, from Merle Hay Road to a point 75 feet east thereof, no parking any time.

Forest Avenue, on the north side, from Merle Hay Road to Sixtieth Street, no parking any time.

Forest Avenue, on the south side, from Sixty-third Street to a point 50 feet east thereof, no parking any time.

Forest Avenue, on the north side, from Cummins Parkway to Sixty-third Street, no parking any time.

Sec. 114-3406. Leyden Avenue--East Thirty-eighth Street to east city limits.

Leyden Avenue, on the north side, from East Thirty-eighth Street to Belmar Drive, no parking any time.

Leyden Avenue, on the south side, from East Thirty-eighth Street to a point 50 feet east thereof, no parking any time.

Leyden Avenue, on the north side, from East Fortieth Street to East Forty-second Street, no parking any time.

Leyden Avenue, on the south side, from a point 140 feet west of East Forty-third Street to dead end east of East Forty-third Court, no parking any time.

Leyden Avenue, on the north side, from Brook Landing Court to the dead end east thereof, no parking any time.

Sec. 114-3602.03. River Meadows Circle—River Ridge Road to cul-de-sac east.

River Meadows Circle, on the north side, River Ridge Road to and including the cul-de-sac east thereof, no parking any time.

Sec. 114-3602.1. River Ridge Road--Southeast Twenty-second Street to dead end south of Riverwoods Avenue.

River Ridge Road, on the west side, from Southeast Twenty-second Street to the dead end south of Riverwoods Avenue, no parking any time.

Sec. 114-3629.05. Shadow Creek Circle—River Ridge Road to cul-de-sac east.

Shadow Creek Circle, on the north side, from River Ridge Road to and including the cul-de-sac east thereof, no parking any time.

Sec. 114-3629.1. Shadow Creek Lane--River Ridge Road to cul-de-sac south of Riverwoods Avenue.

Shadow Creek Lane, on the west side, from River Ridge Road to and including the cul-de-sac south of Riverwoods Avenue, no parking any time.

Sec. 114-3708.01. Village Run Avenue--East Fifty-second Street to east city limits.

Village Run Avenue, on the north side, from East Fifty-second Street to the dead end east of Brook Landing Court, no parking any time.

Sec. 114-3782. Whispering Ridge Drive—River Ridge Road to King Avenue.

Whispering Ridge Drive, on the west side, from River Ridge Road to King Avenue, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
