

ORDINANCE NO. 15,915

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Chapter 114 Sections 114-3235 and 114-3473, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Chapter 114, Sections 114-3235 and 114-3473, relating to traffic and vehicle regulations, as follows:

Sec. 114-3235. East Glenwood Drive--Southeast Fourteenth Street to cul-de-sac east.

East Glenwood Drive, on the south side, from Southeast Fourteenth Street to Southeast Seventeenth Street, no parking any time.

East Glenwood Drive, on the north side, from Southeast Fourteenth Street to a point 75 feet east thereof, no parking any time.

East Glenwood Drive, on the north side from a point 50 feet west of Southeast Seventeenth Street (north leg) to a point 50 feet east of Southeast Seventeenth Street (north leg), no parking any time.

East Glenwood Drive, on the north side, from Southeast Seventeenth Street (south leg) to a point 100 feet west thereof, no parking any time.

East Glenwood Drive, on the south side from Shadow Creek Lane to and including the cul-de-sac east of Deerpath Court, no parking any time.

Sec. 114-3473. Martin Luther King Jr Parkway—Euclid Avenue to Madison Avenue.

Martin Luther King Jr Parkway, on the east side, from Euclid Avenue to Madison Avenue, no parking any time.

Martin Luther King Jr Parkway, on the west side, from Euclid Avenue to a point 200 feet north thereof, no parking any time.

Martin Luther King Jr. Parkway, on the west side, from a point 200 feet north of Euclid Avenue to Lynner Drive, no parking 7:00 A.M. to 6:00 P.M., Monday through Friday.

Martin Luther King, Jr. Parkway, on the west side, from a point 170 feet south of Madison Avenue to Madison Avenue, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
