### ORDINANCE NO. 15,920

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2695, 114-3419, 114-3574, and 114-3781, and adding Section 114-1807, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2695, 114-3419, 114-3574, and 114-3781, and adding Section 114-1807, relating to traffic and vehicle regulations, as follows:

### Sec. 114-1807. Carpenter Avenue

Carpenter Avenue, from Eleventh Street to Thirteenth Street, westbound.

# Sec. 114-2695. Ninth Street--Keosaugua Way to Aurora Avenue.

Ninth Street, on the east side, from Keosauqua Way to a point 250 feet north of Center Street, no parking any time.

Ninth Street, on the east side, from a point 75 feet south of Crocker Street to a point 100 feet north of Crocker Street, no parking any time.

Ninth Street, on the east side, from a point 250 feet north of Center Street to a point 75 feet south of Crocker Street. no parking 4:00 p.m. to 6:00 p.m.

Ninth Street, on the east side, from a point 100 feet north of Crocker Street to Day Street, no parking 4:00 p.m. to 6:00 p.m.

Ninth Street, on the east side, from a point 260 feet south of University to Enos Avenue, no parking 4:00 p.m. to 6:00 p.m.

Ninth Street, on the east side, from University Avenue to a point 260 feet south thereof, no parking any time.

Ninth Street, on the east side from University Avenue to Indiana Avenue, no parking any time. Ninth Street, on the west side, from Keosauqua Way to a point 165 feet north of Center Street, no parking any time.

Ninth Street, on the west side, from a point 165 feet north of Center Street to a point 225 feet south of Crocker Street, no parking 7:00 a.m. to 9:00 a.m.

Ninth Street, on the west side, from a point 225 feet south of Crocker Street to a point 100 feet north of Crocker Street, no parking any time.

Ninth Street, on the west side, from a point 100 feet north of Crocker Street to Day Street, no parking 7:00 a.m. to 9:00 a.m.

Ninth Street, on the east side, from School Street to a point 75 feet south thereof, no parking any time.

Ninth Street, on the east side, from Clark Street to a point 100 feet south thereof, no parking any time.

Ninth Street, on the west side, from Day Street to Hickman Road, no parking any time.

Ninth Street, on the west side, from a point 50 feet south of Euclid Avenue to a point 50 feet north of Euclid Avenue, no parking any time.

Ninth Street, on the west side, from Madison Avenue to a point 50 feet north thereof, no parking any time.

Ninth Street, on the east side, from Oak Park Avenue to Aurora Avenue, no parking any time. Ninth Street, on the west side from a point 365 feet south of Aurora Avenue to Aurora Avenue, no parking any time.

# Sec. 114-3419. Locust Street--Robert D Ray Drive to Second Avenue.

Locust Street, on the south side, from Robert D Ray Drive to a point 125 feet west thereof, no parking any time.

Locust Street, on the north side, from Robert D. Ray Drive to a point 125 feet west thereof, no parking any time.

Locust Street, on the north side, from a point 265 feet east of Second Avenue to a point 35 feet east thereof, commercial loading zone.

Locust Street, on the north side, from Second Avenue to a point 265 feet east thereof, no parking any time.

Locust Street, on the south side, from Second Avenue to a point 85 feet east thereof, no parking any time.

Locust Street, on the north side, from a point 185 feet west of Robert D Ray Drive to a point 505 west thereof, reserved for City of Des Moines municipal employee permit parking, 7:00 a.m. to 4:00 p.m., Monday through Friday.

#### Sec. 114-3574. Pleasant Street--Ninth Street to Tenth Street.

Pleasant Street, on the south side, from Tenth Street to a point 60 feet east thereof, no parking any time.

# Sec. 114-3781. Westwood Drive—Cul-de-sac east of Fifty-sixth Street to Fifty-sixth Street.

Westwood Drive, on the north side, from and including the cul-de-sac east of Fifty-sixth Street to Fifty-sixth Street, no parking any time.

Westwood Drive, on the south side, from a point 50 feet east of Fifty-sixth Street to Fifty-sixth Street, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
