ORDINANCE NO. 15,926

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-361.01(b), 114-2640, 114-2657, 114-3180, 114-3468, and 114-3711, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by Sections 114-2640, 114-2657, 114-3180, 114-3468, 114-361.01(b), and 114-3711, relating to traffic and vehicle regulations, as follows:

Sec. 114-2640. Sixth Avenue--Mulberry Street to Walnut Street.

Sixth Avenue, on the east side, from Mulberry Street to a point 140 feet north thereof, no parking 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m.

Sixth Avenue, on the east side, from a point 140 feet north of Mulberry Street to Walnut Street, no parking any time.

Sixth Avenue, on the west side, from Mulberry Street to a point 100 feet north thereof, loading zone.

Sixth Avenue, on the west side, from 200 feet north of Mulberry Street to a point 45 feet north thereof, commercial loading zone.

Sec. 114-2657. Southeast Sixth Street--East Vine Street to East Porter Avenue.

Southeast Sixth Street, on the west side, from East Vine Street to East Elm Street, no parking any time.

Southeast Sixth Street, on both sides, from East Elm Street to Vale Street, no parking any time.

Southeast Sixth Street, on the east side, from Livingston Avenue to Hartford Avenue, no parking any time.

Southeast Sixth Street, on the west side, from East Livingston Avenue to a point 225 feet south of East Jackson Avenue, no parking any time.

Southeast Sixth Street, on the west side, from a point 225 feet south of East Jackson Avenue to a point 260 feet south thereof, school bus loading zone.

Southeast Sixth Street, on the west side, from a point 485 feet south of East Jackson Avenue to Hartford Avenue, no parking any time.

Southeast Sixth Street, on the east side, from Hartford Avenue to a point 50 feet south thereof, no parking any time.

Southeast Sixth Street, on the west side, from Hartford Avenue to a point 225 feet south thereof, no parking any time.

Southeast Sixth Street, on the east side, from a point 500 feet south of Hartford Avenue to Lacona Avenue, no parking any time.

Southeast Sixth Street, on the west side, from a point 250 feet south of Hartford Avenue to a point 20 feet south thereof, no parking any time.

Southeast Sixth Street, on the west side, from a point 320 feet south of Hartford Avenue to a point 20 feet south thereof, commercial loading zone.

Southeast Sixth Street, on the west side, from Lacona Avenue to a point 65 feet north thereof, no parking any time.

Southeast Sixth Street, on both sides, from Lacona Avenue to Indianola Avenue, no parking any time.

Southeast Sixth Street, on the west side, from East Pleasant View Drive to East Park Avenue, no parking any time.

Southeast Sixth Street, on the west side, from East Trowbridge Street to a point 300 feet south of Scandia Avenue, no parking any time.

Southeast Sixth Street, on the west side, from Spring Street south to and including the cul-de-sac, no parking any time, Thursday, 7:00 a.m. to 4:00 p.m.

Southeast Sixth Street, on the west side, from East Kenyon Avenue to East Porter Avenue, no parking any time.

Sec. 114-3180. East Elm Street--Southeast First Street to Southeast Thirty-sixth Street.

East Elm Street, on both sides, from Southeast Fourth Street to Southeast Fifth Street, no parking any time.

East Elm Street, on both sides, from Southeast Seventh Street to Southeast Tenth Street, no parking any time.

East Elm Street, on the south side, from Southeast Eighteenth Street to Southeast Nineteenth Street, no parking any time.

East Elm Street, on the south side, from Southeast Twenty-sixth Street to Southeast Twenty-eighth Street, no parking any time.

East Elm Street, on the north side, from Southeast Twenty-ninth Street to a point 330 feet east of Southeast Twenty-ninth Court, no parking any time.

East Elm Street, on the south side, from Southeast Thirty-fifth Street to Southeast Thirty-sixth Street, no parking any time.

Sec. 114-3468. East Market Street--Des Moines River to Southeast Twenty-ninth Court.

East Market Street, on the south side, from Southeast Third Street to a point 50 feet west of Southeast Fourth Street, no parking 7:00 a.m. to 6:00 p.m., Monday through Friday.

East Market Street, on the south side, from Southeast Fourth Street to a point 50 feet west thereof, no parking any time.

East Market Street, on the north side, from Southeast Fifth Street to a point 50 feet east thereof, no parking any time.

East Market Street, on the north side, from a point 120 feet east of Southeast Fifth Street to Southeast Sixth Street, no parking any time.

East Market Street, on the south side, from Southeast Fifth Street to a point 75 feet east thereof, no parking any time.

East Market Street, on the south side, from a point 75 feet east of Southeast Fifth Street to Southeast Sixth Street, reserved for City of Des Moines municipal employee permit parking.

East Market Street, on both sides, from Southeast Seventh Street to Southeast Eighth Street, no parking any time.

East Market Street, on the north side, from Southeast Eighteenth Street to Southeast Twentieth Street, no parking any time.

East Market Street, on both sides, from Southeast Twentieth Street to Southeast Twenty-fifth Court, no parking any time.

East Market Street, on the north side, from Southeast Twenty-fifth Court to Southeast Twenty-ninth Court, no parking any time.

East Market Street, on the south side, from Southeast Twenty-seventh Street to a point 100 feet east thereof, no parking any time.

East Market Street, on the south side, from Southeast Twenty-seventh Court to a point 130 feet east thereof, no parking any time.

Sec. 114-361.01. Angle parking.

- (b) The initiation of back-in angle parking at any location is prohibited except at the following locations:
 - (1) Court Avenue, on the south side, from Water Street to East Third Street.
 - (2) Walnut Street, on the north side, from Water Street to East First Street.
 - (3) East Fourth Street, on the west side, from Locust Street to Grand Avenue.
 - (4) East Fourth Street, on both sides, from Grand Avenue to Des Moines Street.
 - (5) East Fifth Street, on the east side, from Walnut Street to Grand Avenue.
 - (6) Shaw Street, on the south side, from Southeast Fifth Street to Southeast Sixth Street.
 - (7) Twenty-third Street, on the west side, from Ingersoll Avenue to High Street.
 - (8) Chamberlain Avenue, on the north side, from Forty-second Street to a point 135 feet west thereof.
 - (9) Southeast Seventh Street, on the west side, from East Vine Street to East Elm Street.
 - (10) East Vine Street, on the south side, from Southeast Sixth Street to Southeast Seventh Street.

Sec. 114-3711. East Vine Street--Southeast First Street to Southeast Sixteenth Court.

East Vine Street, on both sides, from Southeast First Street to Southeast Sixth Street, no parking any time.

East Vine Street, on the south side, from a point 55 feet east of Southeast Sixth to a point 15 east thereof is designated a handicapped parking area and is subject to the same prohibition as is found in subsection 144-616(a) of this chapter.

East Vine Street, on both sides, from Southeast Seventh Street to Southeast Eight Street, no parking any time.

East Vine Street, on the north side, from Southeast Fourteenth Court to Southeast Sixteenth Court, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
