#### ORDINANCE NO. 16,255

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-319.03, 114-1547, 114-1318, 114-2606, 114-2781, 114-3259, and 114-3655, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-319.03, 114-1547, 114-1318, 114-2606, 114-2781, 114-3259, and 114-3655, relating to traffic and vehicle regulations, as follows:

## Sec. 114-319.03. Location of four-way stop intersections.

The following intersections are designated as four-way stop intersections. Stop signs shall be installed and maintained at the following intersections, and the driver of a vehicle approaching these intersections from all directions shall stop in accordance with this chapter before entering the intersections:

(66a) South Union Street and Leach Avenue.

## Sec. 114-1547. Repealed by Ord. No. 16,255.

#### Sec. 114-1318. Franklin Avenue.

Franklin Avenue, from Merle Hay Road to Sixty-third Street, 30 miles per hour.

#### Sec. 114-2606. Third Street--Locust Street to Grand Avenue.

Third Street, on the east side, from Locust Street to a point 150 feet north thereof, no parking any time.

Third Street, on the east side, from a point 196 feet north of Locust Street to a point 27 feet north thereof, is designated a handicapped loading zone, 30-minute limit, and is subject to the same prohibitions as are found in subsection 114-616(a) and in section 114-608 of this chapter.

Third Street, on the east side, from a point 150 feet north of Locust Street to a point 46 feet north thereof, loading zone.

Third Street, on the east side, from a point 223 feet north of Locust Street to Grand Avenue, no parking any time.

Third Street, on the west side, from a point 65 feet north of Locust Street to a point 20 feet north thereof, commercial loading zone.

Third Street, on the west side, from Grand Avenue to a point 65 feet south thereof, no parking any time.

### Sec. 114-2781. Eighteenth Street--Locust Street to Ingersoll Avenue.

Eighteenth Street, on both sides, from Locust Street to Grand Avenue, no stopping or standing.

Eighteenth Street, on the east side, from Grand Avenue to a point 35 feet north thereof, no parking any time.

# Sec. 114-3259. Grand Avenue--Seventeenth Street to Eighteenth Street.

Grand Avenue, on the north side, from Seventeenth Street to a point 30 feet west thereof, no parking any time.

Grand Avenue, on the south side, from Seventeenth Street to a point 225 feet west thereof, school passenger loading and unloading, 3 7:00 a.m. to 4:00 p.m. school days, 30-minute limit.

Grand Avenue, on the south side, from a point 225 feet west of Seventeenth Street to Fleur Drive, no parking any time.

Grand Avenue, on the north side, from a point 330 feet west of Seventeenth Street to Eighteenth Street, no parking any time.

## Sec. 114-3655. South Union Street--Park Avenue to Army Post Road.

South Union Street, on both sides, from Park Avenue to Leach Avenue, no parking any time.

South Union Street, on the west side, from Leach Avenue to Army Post Road, no parking any time.

South Union Street, on the east side, from East Leach Avenue to a point 255 feet south thereof, no parking any time.

South Union Street, on the east side from a point 255 feet south of East Leach Avenue to a point 350 feet south thereof, school passenger loading and unloading 7:00 a.m. to 5:00 p.m., school days.

South Union Street, on the east side from a point 605 feet south of East Leach Avenue to Army Post Road, no parking anytime.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
