WHEREAS, the City Plan and Zoning Commission has advised that at a public hearing held on December 21, 2006, its members voted 11-0 to recommend APPROVAL of a request from Grand View College (owner) represented by Scott Bock (officer) to vacate and convey all of the east/west alley between Grandview Avenue and Boyd Street from East 13<sup>th</sup> Street to East 14<sup>th</sup> Street; a segment of east/west alley between Morton Avenue and East Sheridan Avenue from East 14<sup>th</sup> Street to a point approximately 100 feet to the west; all portions of the east/west and north/south alley between Grandview Avenue and Morton Avenue from East 13<sup>th</sup> Street to a point 250 feet west of East 14<sup>th</sup> Street; and all of Grandview Avenue between East 13<sup>th</sup> Street and East 14<sup>th</sup> Street subject to the following:

- 1. Reservation of easements for all utilities in place until such time that they are eliminated or relocated at the applicant's expense.
- 2. Provision of access easements within alley right-of-ways until such time that all adjoining properties have been acquired by Grand View College.
- 3. Provision of a permanent access easement across Grandview Avenue rightof-way to afford access for emergency vehicles and fire apparatus.
- 4. Installation of removable bollards at the east and west ends of Grandview Avenue right-of-way.
- 5. The private road within vacated Grandview Avenue right-of-way shall be marked with permanent "NO PARKING FIRE LANE" signs with red letters on a white reflective background that have a minimum dimension of 12"-wide by 18"-high.
- 6. Provision of a cross access easement to provide ingress/egress to the remaining segment of east/west alley bisecting the block between Morton Avenue and Sheridan Avenue.
- 7. The property at 1300 Grandview Avenue is re-addressed with an East 13<sup>th</sup> Street address.
