WHEREAS, the Des Moines City Council approved on Roll Call 06-098 an annual maintenance agreement with Intergraph Corporation, PO Box 6695, Huntsville, Alabama 35824-0695, Chief Operations Officer Ben Eazzette to support the police and fire department's Computer Aided Dispatch and Records Management System; and,

WHEREAS, the police and fire department's Computer Aided Dispatch and Records Management System software maintenance agreement with Intergraph Corporation, PO Box 6695, Huntsville, Alabama 35824-0695, Chief Operations Officer Ben Eazzette has expired; and,

WHEREAS, Intergraph Corporation, PO Box 6695, Huntsville, Alabama 35824-0695, Chief Operations Officer Ben Eazzette has provided a renewal agreement, which includes software for the new Mobile Data System being constructed by the police and fire departments; and,

WHEREAS, this contract meets the requirements of Municipal Code section 2-726 (a)(7) which provides for a non-competitive procurement of goods and/or services that are of such a nature that they are the only goods and/or services which will fit and comply with the required use, or are an integral part of a total system so as to be uniquely compatible with existing city need, materials or equipment to be cost effective; and

WHEREAS, the police and fire departments depend on this software to accurately and rapidly respond to requests for service from the citizens of Des Moines; and,


WHEREAS, the cost of the new annual maintenance agreement is \$132,125.00, which will be funded out of the E911 Surcharge fund and out of the police department's general operating budget; and,
