APPROVING AN EXCEPTION TO THE PROCUREMENT ORDINANCE COMPETITIVE BIDDING REQUIREMENTS FOR GOOD CAUSE AND APPROVING A CONTRACT WITH CARPENTER UNIFORM & PROMOTIONAL PRODUCTS FOR SERVICES TO THE CITY OF DES MOINES, IOWA POLICE DEPARTMENT

WHEREAS, The Carpenter Uniform & Promotional Products, 5801 Thornton Ave., Des Moines, Iowa 50321, President Robert Carpenter has provided uniform services to the City of Des Moines Police Department for a number of years and the current contract with this company expired in March 2006; and

WHEREAS, a new contract with this company is in the best interest of the City concerning product availability, delivery, repairs and alterations; and

WHEREAS, no other local businesses can meet service specifications in their entirety; and

WHEREAS, the City Manager recommends that the above described procurement be exempted from competitive bidding requirements for good cause shown, pursuant to Section 2-710(a) of the Municipal Code of the City of Des Moines, Iowa; and

WHEREAS, a new contract has been completed and approved by City staff and Carpenter Uniform & Promotional Products ; and


WHEREAS, the term of this contract is for three years with a renewal option of a like period at the discretion and signature of the Chief of Police.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

- 1 That good cause has been shown to exempt the procurement of uniform services from the Procurement Ordinance competitive bidding requirements.
2. That the City Council hereby approves the, herein mentioned, negotiated contract with Carpenter Uniform & Promotional Products, 5801 Thornton Ave., Des Moines, Iowa 50321, President Robert Carpenter and authorizes the Mayor of Des Moines, Iowa to sign said contract and have the City Clerk attest to his signature.
