## LEGISLATIVE UPDATE January 22, 2007

January 8, 2006 marked the first day of the 2007 Legislative Session. Governor Chet Culver and Lt. Governor Patty Judge took office on Friday, January 12th in a ceremony at the Wells Fargo Arena in Des Moines.

In his Inaugural Address, Governor Culver said: "As Iowans, I think we could do much worse than to learn from the lessons provided by those who have come before us.

He said "Right now, Iowa is experiencing much the same change and with it comes the opportunity for a new era of greatness. ... Well, my fellow Iowans, this is our time! It's our time to accept the challenge, to explore and discover Iowa's unlimited potential. It's our time to win the race to become the energy capital of the world. Let us invoke the lessons previous generations of explorers and leaders have taught us. Let us all come together as one and lead our own 21st Century Iowa Expedition."

The Governor also said "to the 150 dedicated lowans who serve in the 82nd General Assembly, I say this: may our inevitable disagreements reflect deep conviction but not contempt, honest difference but not divisiveness. Let us work together in a sincere and inclusive way to create One Iowa. But a Governor can't do it alone. That's why today, I am asking for your help. Especially, the next generation of Iowans. Everyone has a role to play in our '21st Century Expedition.'"
