AUTHORIZING REQUEST TO IDOT TO TERMINATE IDOT AGREEMENT FOR FLEUR UNDERPASS PROJECT AND REALLOCATION OF FUNDING AND AUTHORIZING NEGOTIATION AND EXECUTION OF TERMINATION AGREEMENT OF 28E AGREEMENT WITH WATER WORKS FOR SAME PROJECT

WHEREAS, on June 20, 2005, under Roll Call 05-1577, the City Council approved and authorized the execution of an agreement between the City of Des Moines and the Iowa Department of Transportation for the Fleur Trail Connector and a Chapter 28E agreement between the City of Des Moines and the Board of Water Works Trustees of the City of Des Moines for Construction and Funding of the Fleur Trail Underpass Project; and

WHEREAS, the Fleur Trail Connector was awarded Surface Transportation Program Transportation Enhancement funds not to exceed \$573,090 with Iowa Department of Transportation Agreement 05-STPES-147; and

WHEREAS, on December 5, 2005, under Roll Call 05-2421, the City Council rejected all bids because the low bid of \$1,032,017.20 exceeded the project budget and Des Moines Water Works was unable to obtain sufficient donations to fund the local share of the project; and

WHEREAS, the Des Moines Water Works have requested termination of the Chapter 28E agreement for Construction and Funding of the Fleur Trail Underpass Project and reallocation of up to \$227,500 of the Surface Transportation Program Transportation Enhancement funds to the Fleur Drive Beautification project; and

WHEREAS, the Fleur Drive Beautification project will be managed and funded by the Des Moines Water Works; and

WHEREAS, reallocation of Surface Transportation Program Transportation Enhancement funds requires consideration and approval by the Iowa Department of Transportation Commission.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

1. That the City Manager is directed to prepare and the Mayor is authorized to sign a request to the Iowa Department of Transportation to terminate the Fleur Trail Connector Agreement and to request reallocation of \$227,500 of the Surface Transportation Program Transportation Enhancement funds from the Fleur Trail Underpass Project to the Fleur Drive Beautification project.
