## RESOLUTION APPROVING REVITALIZE IOWA'S SOUND ECONOMY (RISE) GRANT AGREEMENT TO CONSTRUCT AND RECONSTRUCT A ROADWAY IN THE RIVERPOINT WEST AREA (SW 11<sup>TH</sup> STREET FROM MARTIN LUTHER KING, JR. PARKWAY TO DART WAY)

WHEREAS, on May 23, 2005 by Roll Call No. 05-1331, the City Council of the City of Des Moines ("City") entered into a Preliminary Agreement with Hubbell Realty Company, Hubbell Terminal Corporation and Riverpoint West, LLC for redevelopment of land west of SW 9<sup>th</sup> Street in the vicinity of Tuttle and Murphy Streets and commonly referred to as the Riverpoint West area; and

WHEREAS, the City agreed to seek a RISE grant to pay for the construction of streets to facilitate redevelopment in the Riverpoint West area; and

WHEREAS, on September 12, 2005 by Roll Call No. 05-2217, the City Council of the City of Des Moines ("City") approved a Revitalize Iowa's Sound Economy (RISE) grant application for \$875,000 to construct and reconstruct SW 11<sup>th</sup> Street from Martin Luther King, Jr. Parkway to Dart Way (f/k/a MTA Lane), Murphy Street from SW 9<sup>th</sup> to SW 11<sup>th</sup> Streets and Tuttle Street from SW 11<sup>th</sup> Street to 300' east in the Riverpoint West area; and

WHEREAS, the Iowa Department of Transportation approved a grant of up to \$521,290 for RISE-eligible costs to construct and reconstruct SW 11<sup>th</sup> Street from Martin Luther King, Jr. Parkway to Dart Way; and

WHEREAS, it is required that the City enter into the RISE Project Agreement No. 2006-R-010 to receive the grant.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines that:

- 1. The Revitalize Iowa's Sound Economy (RISE) grant agreement (No. 2006-R-010) for the proposed construction and reconstruction of portions of SW 11<sup>th</sup> Street, on file in the Office of the City Clerk, is hereby approved and ratified.
- 2. The Mayor is hereby authorized and directed to sign the RISE grant agreement (No. 2006-R-010) on behalf of the City of Des Moines.
