LEGISLATIVE UPDATE February 26, 2007

Legislators continue to work on property tax relief. Rep. Wise, who is chairing the House working group on the commercial property tax, introduced HF 418, to create an income tax credit for three years (\$275 in 2007, and \$550 in 2008 & 2009) for commercial property tax payers.

Rep. Struyk and Rep. Huser held a subcommittee meeting on HF 219, which they introduced, to exempt recreational properties such as ski areas and golf courses from property taxes. The bill is SF 105 in the Senate.

Governor Culver said that Lt. Governor Judge will serve as the Governor's Homeland Security Advisor and replaces General Ron Dardis. The Homeland Security Advisor is responsible for overseeing homeland security activities, including budget and policy issues.

Culver said "As I have always said, this Administration is a true partnership and I am very pleased to announce Lt. Governor Judge as my new Homeland Security Advisor. She has experience in homeland security and this role is clearly a natural fit. As my Homeland Security Advisor, Lt. Governor Judge will serve to not only keep me informed and advise me regarding all issues of security in and around our state, but she will also work with the federal Homeland Security Department to make sure lowa's interests are known and understood around the country. In addition, she will work with other state agencies to ensure our government is ready for disasters both natural and man made, and work with other states to ensure that lowa is at the forefront of preparedness and we are not caught asleep at the wheel."

Culver said that Judge worked on the Center for Agriculture Security when she was Secretary or Agriculture. The Center coordinates livestock and crop security and works with local, state and national agencies.

Allows the employer to arrange for an examination of the injured employee but requires that the employee be paid, including for costs. Allows the employer to confer with the physician. Requires the employee to agree to the exam, and suspends any rights to compensation if the employee refuses. Allows the employee to seek a second opinion of the extent of disability at the owner's expense.
