HOLD HEARING FOR THE VACATION AND CONVEYANCE OF A PARCEL OF PROPERTY IN EWING PARK, SOUTH OF FIRE STATION NO. 10, TO BLOOMFIELD UNITED METHODIST CHURCH FOR \$7,500

WHEREAS, on January 9, 2006, by Roll Call No. 06-074, the City Council moved to receive, file and refer a request from Bloomfield United Methodist Church for vacation and conveyance of a parcel of property in Ewing Park, hereinafter more fully described, to the City Manager and Park and Recreation Board for review and recommendation; and

WHEREAS, on January 24, 2006, by Resolution No. 06-008, the Park and Recreation Board approved the vacation and conveyance of such City-owned property; and

WHEREAS, the grantee identified below is the owner of property abutting such parcel of Ewing Park and has offered to the City of Des Moines the purchase price identified below for the vacation and purchase of the portion of Ewing Park described below; and

WHEREAS, on February 12, 2007, by Roll Call No. 07-233, it was duly resolved by the City Council that the proposed vacation and conveyance of a portion of Ewing Park be set down for hearing on February 26, 2007, at 5:00 p.m., in the Council Chamber; and

WHEREAS, on February 12, 2007, the City Council authorized the publication of a notice to vacate and convey the subject property for \$15,000. Since this date, the City's Engineering Department has determined that a portion of the subject property may be needed for possible future extension of East Payton Avenue to accommodate a new school that is planned to be located on a portion of the Ewing Park Property. The reservation of an easement for this possible street extension reduces the fair market value of the property being sold by 50% or from \$15,000 to \$7,500; and

WHEREAS, due notice of said proposal to vacate and convey such parkland for \$7,500, reserving an easement for street right-of-way across the South ½ of the property being conveyed, was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with said notice, those interested in said proposed vacation and conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

1. Upon due consideration of the facts and statements of interested persons, the objections to said proposed vacation and conveyance, as described below, are hereby overruled and the hearing is closed.
