RESOLUTION ACCEPTING ASSIGNMENT OF TAX SALE CERTIFICATE FROM OAK HELM PARTNERS FOR VACANT LOT LOCATED AT 1622 FOREST AVENUE FOR REDEVELOPMENT AS AFFORDABLE HOUSING

WHEREAS, Iowa Code §446.19A permits cities to acquire tax sale certificates for vacant lots and for abandoned property assessed as residential property or as commercial multifamily property at a tax sale without paying the taxes then due, to obtain the assignment of outstanding tax sale certificates by payment to the holder in the amount then due to redeem the certificate, and to give notice of expiration of the redemption period upon an expedited schedule, all for the purpose of encouraging the acquisition and rehabilitation of abandoned dwellings and the development of vacant lots for residential use; and,

WHEREAS, by Roll Call No. 05-2584, the Des Moines City Council approved the Forest Avenue Urban Renewal Plan, which identified 1622 Forest Avenue as an acquisition parcel for the development of affordable housing; and

WHEREAS, acquiring the parcel through the tax sale certificate process will be substantially less expensive than through the Urban Renewal process, which will further enhance the affordability of the home; and,

WHEREAS, OHP 1, L.C., a subsidiary of Oak Helm Partners, has offered to sell the 2003 tax sale certificate to the City of Des Moines for \$260.00, which represents the actual costs that they have in the property; and,

WHEREAS, by receiving the assignment of the 2003 tax sale certificate, the City of Des Moines will be able facilitate the development of affordable housing by completing the necessary legal work prior to reassigning the tax sale certificate to a developer who will develop affordable housing on the vacant lot; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. The assignment to the City of Des Moines of the 2003 tax sale certificate for 1622 Forest Avenue by Oak Helm Partners is hereby approved and accepted.
- 2. The Finance Director is authorized to issue a check payable to OHP 1, L.C., in the amount of \$260.00 for the assignment of this certificate to the City of Des Moines, and to pay any additional fees required by the Polk County Treasurer's Office to file and record the assignment.


