APPROVING AND AUTHORIZING THE EXECUTION OF FEDERAL AVIATION ADMINISTRATION AIP GRANT AGREEMENT, PROJECT NUMBER 3-19-0027-54

AIRPORT ACCESS CONTROL & VIDEO SURVEILLANCE EQUIPMENT UPGRADE

WHEREAS, on March 2, 2010 by Roll Call A10-045, the Airport Board approved the Contract and Bond and Permission to Sublet Subject to FAA concurrence of the award

WHEREAS, on March 2, 2010 by Roll Call A10-048, the Airport Board recommended acceptance of FAA Airport Improvement Grant No. 3-19-0027-54 in a Federal Share Amount of \$1,022,675.00 or any other amount that FAA may make available for the Access Control and Video Surveillance Equipment Upgrade Project

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

- 1. That the City of Des Moines, Iowa, does hereby approve execution and acceptance of a Federal FAA Grant for Access Control and Video Surveillance Equipment Upgrade Project.
2. That the City of Des Moines, Iowa, does hereby ratify and adopt all statements, representations, assurances, warranties, covenants, and agreements contained in the Project Application, a copy of which is on file in the office of the City Clerk.
3. That the Mayor is hereby authorized and directed to execute said AIP Grant, Project No. 3-19-0027-54, in a 95% Federal Share amount anticipated to be \$1,022,675.00 or any such amount offered to the City of Des Moines, Iowa, whether it may be more or less than the anticipated amount, the City Clerk shall attest to the signature, and the Legal Department is authorized to evaluate and certify on behalf of the City of Des Moines, Iowa, that the grant agreement execution is legal and binding according to state and local law.
