RESOLUTION APPROVING DIVISION ASSESSMENT SCHEDULE  
GRANDSHIRE AREA SANITARY SEWER PROJECT  
4410 SE 16<sup>th</sup> STREET

WHEREAS, on March 10, 2003, under Roll Call No. 03-471, the City Council approved and levied the final Schedule of Assessments No. 1995-07 for Grandshire Area Sanitary Sewer Project, Activity ID 07-1995-010, which included a \$8,285.71 assessment against the vacant lot at 4410 SE 16<sup>th</sup> Street, District/Parcel 120/01826-511-000, Lot 11 Grandshire, being \$3,750.00 due and payable at that time and a deficiency assessment of \$4,535.71; and

WHEREAS, the originally assessed parcel (Lot 11 Grandshire with an area of 37,296 SF) has been split into two parcels being:

- N 90F Lot 11 Grandshire, District/Parcel 120/01826-511-001, with an area of 25,848 SF. There was an improvement to this new parcel (BLD2007-00973). In accordance with Section 384.63 of the Iowa Code the \$4,535.71 deficiency assessment has been divided pro rata with \$3,140.11 assigned to this parcel.
- EX N 90F Lot 11 Grandshire, District/Parcel 120/01826-511-002, with an area of 11,448 SF. In accordance with Section 384.63 of the Iowa Code the \$4,535.71 deficiency assessment has been divided pro rata with the remaining \$1,395.60 assigned to this parcel.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached Division Assessment Schedule dividing final special assessments shown on SE Grandshire Area Sanitary Sewer Project, Activity ID 07-1995-010 Schedule Number 1995-07, be and is hereby approved; and the City Clerk is hereby authorized and directed to certify said Division Assessment Schedule to the County Treasurer for spreading said assessments against properties as shown in said Division Assessment Schedule, in lieu of the original assessment.
