SET HEARING FOR THE CONVEYANCE OF A PERMANENT ELECTRIC LINE EASEMENT ACROSS CITY-OWNED PROPERTY AT 602 ROBERT D. RAY DRIVE TO MIDAMERICAN ENERGY COMPANY FOR \$1.00

WHEREAS, MidAmerican Energy Company requires a Permanent Electric Line Easement across City-owned property at 602 Robert D. Ray Drive for the general public purpose of construction, operation and maintenance of an upgraded transformer to accommodate increased electric load for the Ice Skating and Fountain Plaza Project, such property interests more specifically described below.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

- 1. The City Council of the City of Des Moines, Iowa proposes to grant a Permanent Electric Line Easement across the following described property at 602 Robert D. Ray Drive, more specifically described and for the consideration identified below:

To: MidAmerican Energy Company
For: \$1.00

An electric line easement 10 feet wide by 10 feet long situated in Block 1 in East Fort Des Moines, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

- 2. A public hearing shall be held on May 8, 2006 at 5:00 p.m. in the City Council Chamber, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa. At that time the City Council will consider the above-described proposal and any other(s) submitted prior to or during the public hearing.
3. The City Clerk is hereby authorized and directed to publish notice of said proposal and hearing in the form hereto attached, all in accordance with code section 362.3 of the Iowa Code.
4. There will be no proceeds associated with the conveyance of this easement.

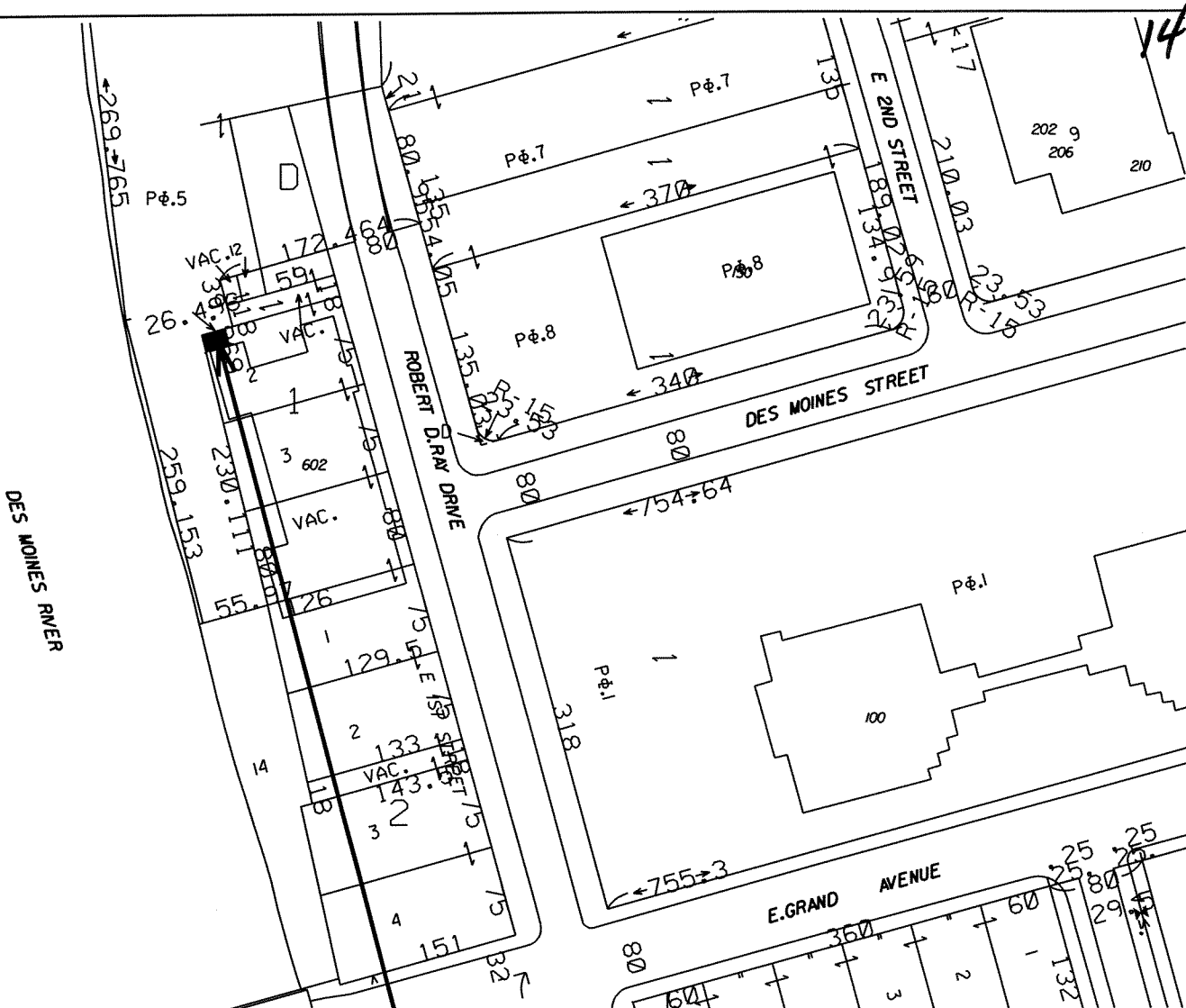

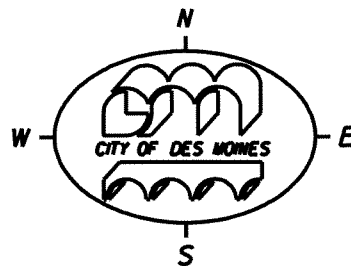
