WHEREAS, on April 22, 2002, by Roll Call No. 02-1063, City Council approved Second Amendment to the Land Lease Agreement with UPS; and

WHEREAS, on December 8, 2003, by Roll Call No. 03-2785, City Council approved the Third Amendment to the Land Lease Agreement with UPS; and

WHEREAS, on February 7, 2005, by Roll Call No. 05-348, City Council approved the Fourth Amendment to the Land Lease Agreement with UPS; and

WHEREAS, the Aviation Department staff and UPS have negotiated a Fifth Amendment to the Land Lease Agreement, and

WHEREAS, on May 2, 2006 by Resolution A06-88, the Des Moines International Airport Board recommended City Council approval of the Fifth Amendment to the Land Lease Agreement with UPS,

WHEREAS, on May 8, 2006, by Roll Call No. 06-890, City Council directed the City Clerk to publish the notice of said proposal to set a date of public hearing for May 22, 2006; and
