On May 16, 2006, Grimes Asphalt & Paving Corp., J M Yonker, President, 12021 NW 54th Avenue, Grimes, IA 50111 submitted a proposal for construction of the Bill Riley Trail HMA Overlay, Activity ID 11-2004-003, which the City Council has determined to be the lowest responsible, responsive bid for said project in the amount of \$240,331.67.
