ORDERING CONSTRUCTION OF
2006 CITY-WIDE PCC PAVEMENT RESTORATION PROGRAM
AND FIXING A DATE FOR RECEIVING OF BIDS ON JUNE 27, 2006
AND PUBLIC HEARING ON JULY 10, 2006
ENGINEER'S ESTIMATE IS \$178,800.00

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached communication recommending construction of the following improvement and the method of financing; and also including the recommendation of the Des Moines City Engineer, as the Jurisdictional Engineer, submitting plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of cost for the construction of the following improvement:

2006 City-wide PCC Pavement Restoration Program, 06-2006-022

The improvement includes work to furnish, place, cure, saw, and seal PCC Pavement Patches of various thickness in a cooperative effort with the City of Des Moines, Public Works Department, at the following Des Moines locations:

- Bel Aire Road from Beaver Avenue to 50th Street
- Merced Avenue from 51st Street to 54th Street
- New York Avenue from 56th Street to Merle Hay Road
- Dixon Street from Euclid Avenue to E. Hull Avenue
- Dixon Street from Hull Avenue to Guthrie Avenue
- Euclid Avenue from E. 42nd Street to E. 43rd Street
- Grandview Avenue from E. 42nd Street to dead end East
- Cummings Parkway from University Avenue to Dagle Drive
- SW 19th Street from Porter Avenue to Kenyon Avenue
- SW 62nd Street from Tonka Avenue to Railroad Avenue
- Leach Avenue from South Union Street to SW 5th Street
- SE 31st Street from E. Porter Avenue to Easter Lake Drive
- SW 8th Street From Wall Avenue to Payton Avenue

be and the same are hereby approved and accepted. The estimated construction cost for said improvement is \$178,800.00. The proposed plans, specifications, and form of contract documents are available for public inspection in the City Engineer's Office.

BE IT FURTHER RESOLVED: That this Council hereby determines that it is necessary and advisable to construct said improvement in the manner set forth in the plans, specifications, and form of contract documents submitted by the Jurisdictional Engineer; and that payment for the cost of said improvement shall be paid from from the funding source identified below.

BE IT FURTHER RESOLVED: That a public hearing on said plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost for said improvement be held in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa, at 5:00 p.m. on July 10, 2006, at which time this Council will consider any objections offered thereto or to the making of said improvement.

BE IT FURTHER RESOLVED: That an appropriate Notice to Bidders and Notice of Public Hearing for said improvement be published in the Des Moines Register as provided and directed by Chapter 384, Code of Iowa.



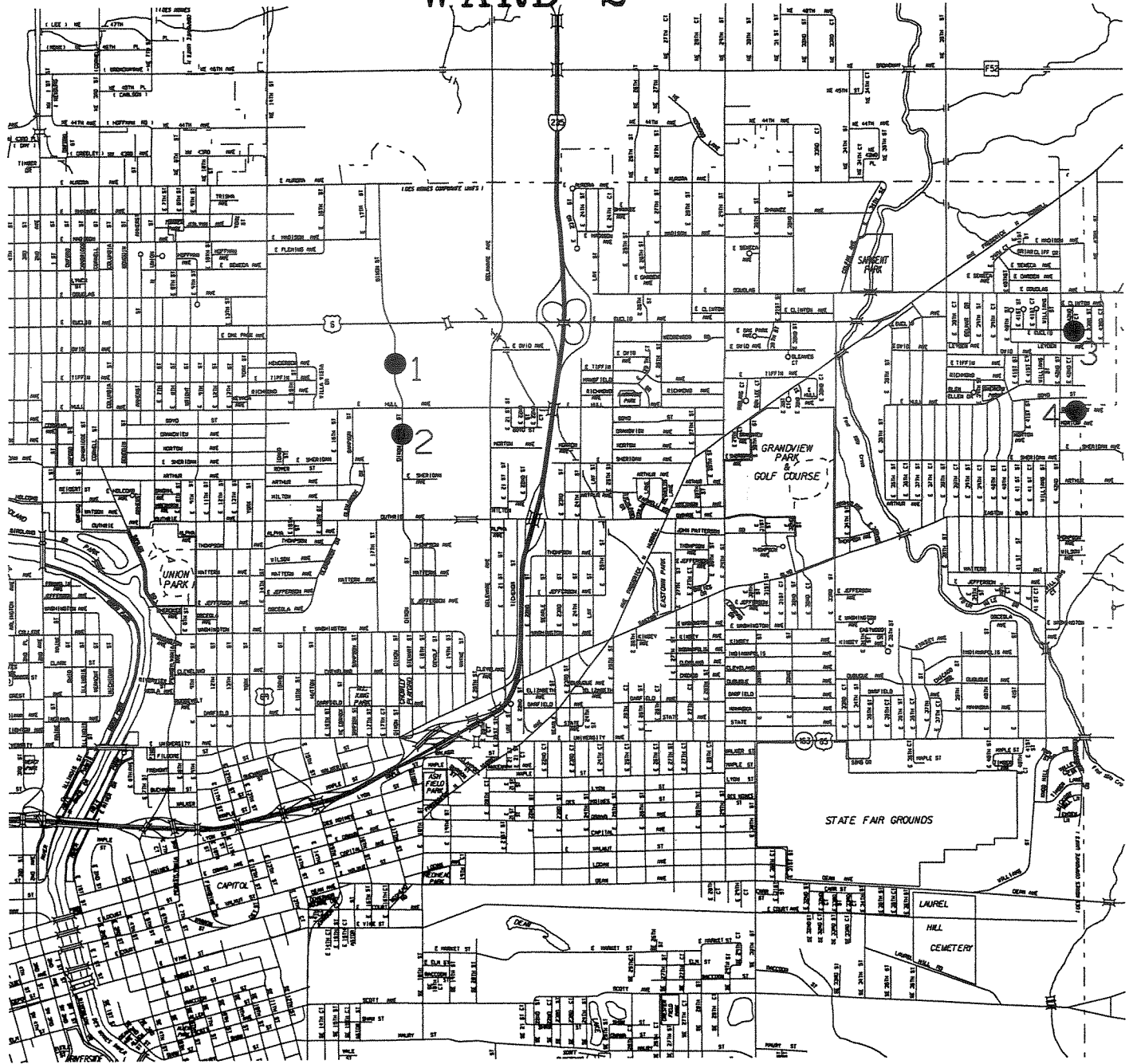
1. BEL AIRE RD. - BEAVER TO 50TH

3. NEW YORK AV. - 56TH TO MERLE HAY RD.



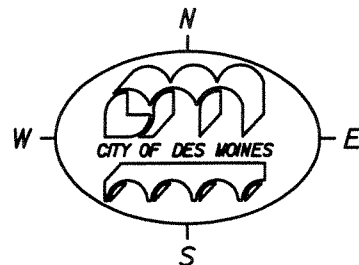

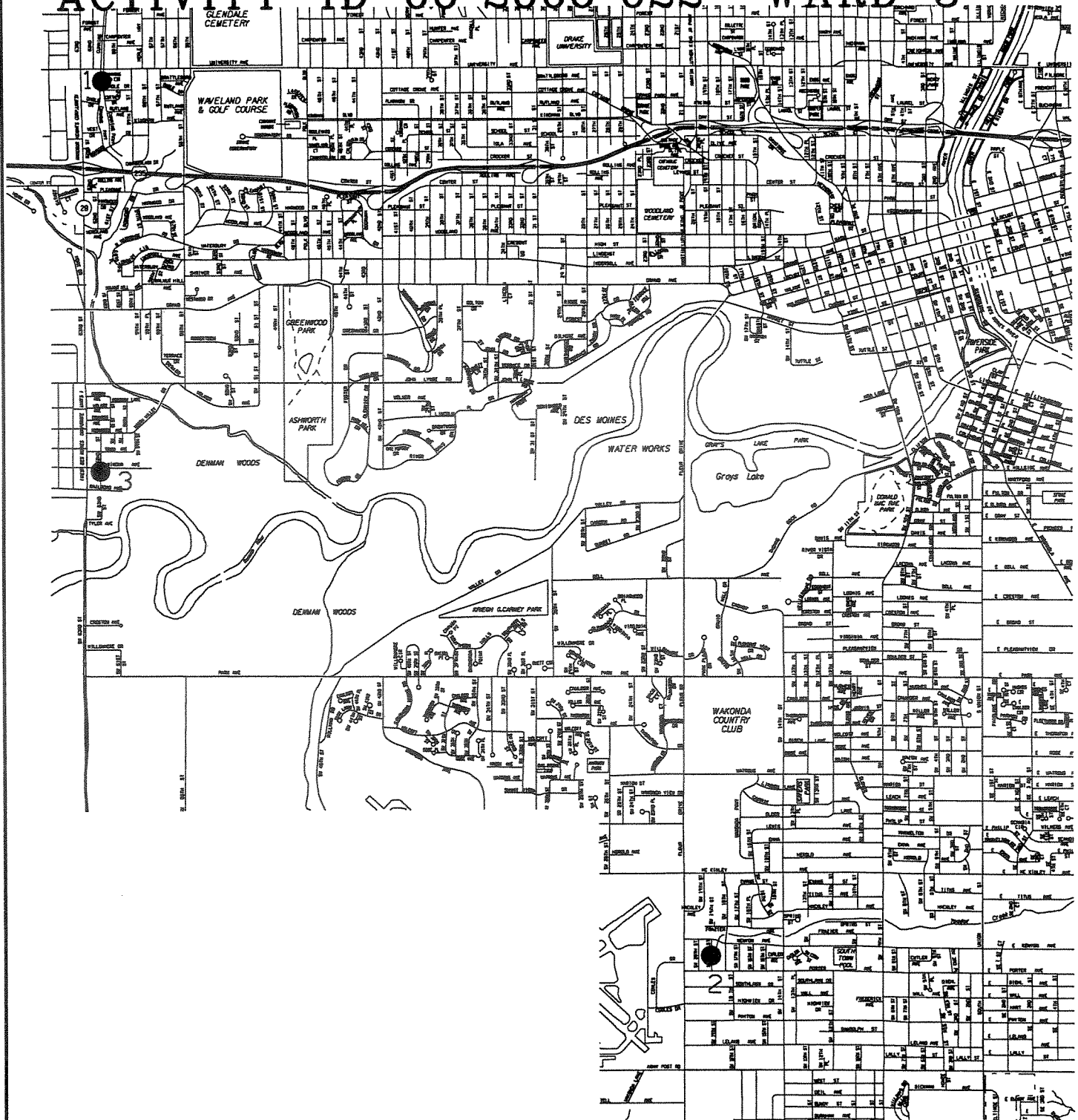


1. DIXON ST. - ECLID TO HULL

4. GRANDVIEW AV. - E. 42ND TO DEAD END EAST

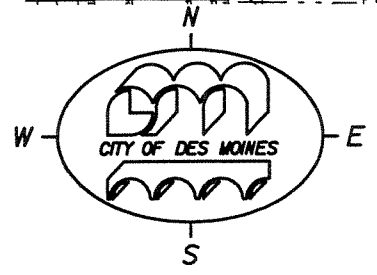

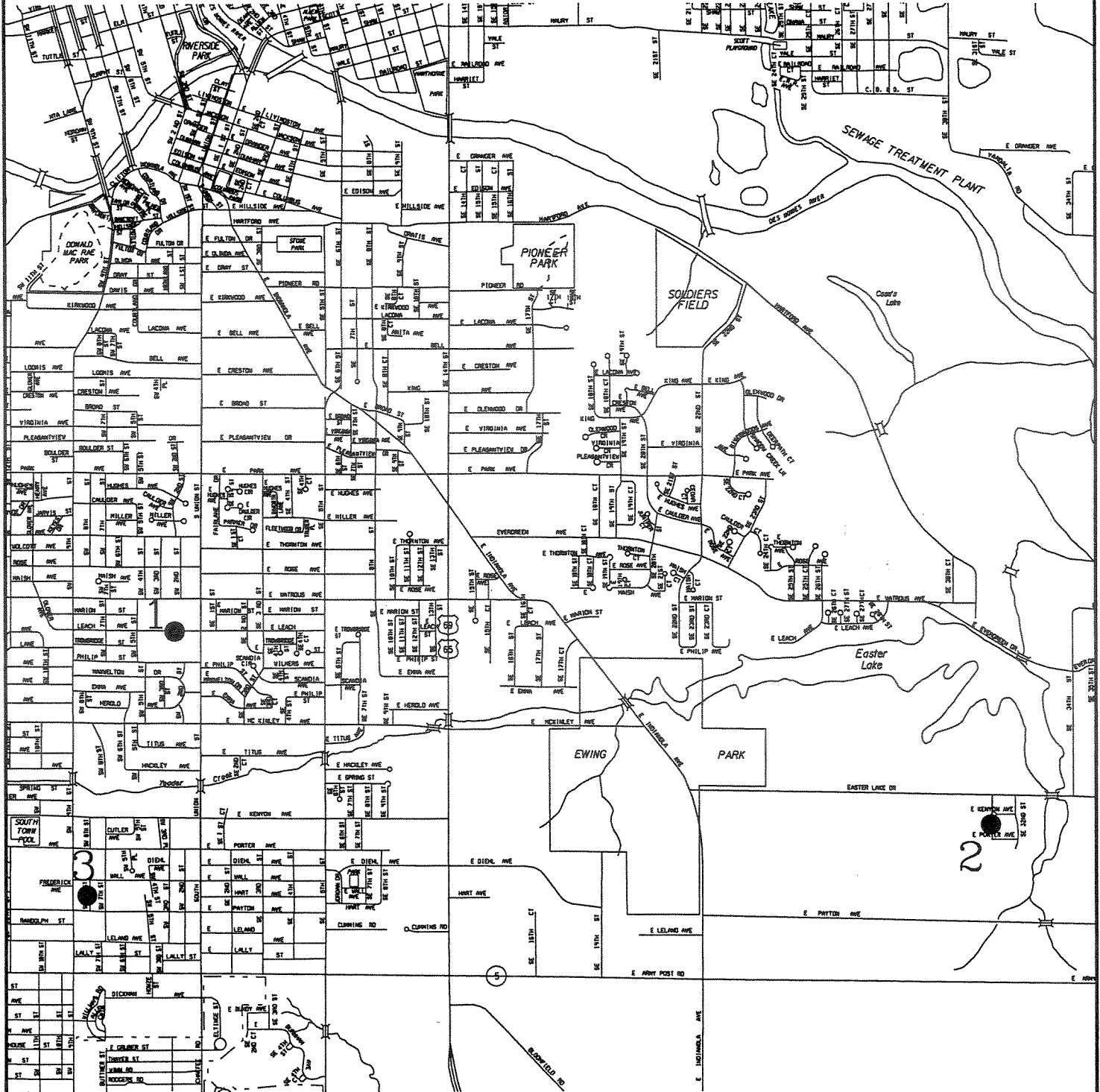
1. CUMMINGS PWK. - UNIVERSITY TO DAGLE DR.

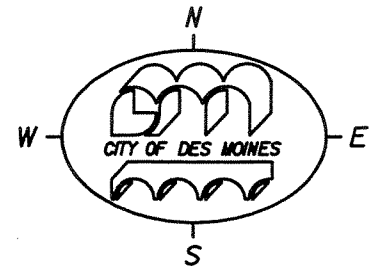


