ORDINANCE NO. \_\_\_\_\_

AN ORDINANCE vacating the west 6.0 feet of the North/South alley right-of-way in the block bounded by 9th, 10th, Walnut and Mulberry Streets.

WHEREAS, all prior requirements of law pertaining to the vacation of public right-of-way have been fully observed; and

WHEREAS, it is desirable that the public right-of-way herein described be vacated; NOW, THEREFORE,

BE IT ORDAINED by the City Council of the City of Des Moines, Iowa:

Section 1. That the west 6.0 feet of the North/South alley right-of-way in the block bounded by 9th, 10th, Walnut and Mulberry Streets, more specifically described as follows, be and is hereby vacated:

The West 6.0 feet of the East 12.0 feet of Lot 6, except the North 19.40 feet thereof, in John A. Garver's Subdivision of Lots 5 and 6, in Block 2, in West Fort Des Moines, an Official Plat; and, the East/West alley right-of-way lying South of and

adjoining the West 6.0 feet of the East 12.0 feet of said Lot 6; and, the West 6.0 feet of the East 12.0 feet of Lot 7, in Block 2, in West Fort Des Moines, an Official Plat; and, the West 6.0 feet of the East 12.0 feet of Lots 7 and 8, in Block 12, in H.M. Hoxie's Addition to Fort Des Moines, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

Sec. 2. That the City Clerk is hereby authorized and directed to cause a certified copies of this ordinance and proof of publication thereof together with proof of publication of the notice of the public hearing on this matter to be properly filed in the office of the Recorder of Polk County, Iowa.

Sec. 3. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
