PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON WARREN COUNTY ROADWAY IMPROVEMENTS - PHASE 2; RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIBLE, RESPONSIVE BIDDER AS GRIMES ASPHALT & PAVING CORP., J M YONKER, PRESIDENT, \$92,299.80

WHEREAS, on May 22, 2006, under Roll Call No. 06-974, plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

Warren County Roadway Improvements - Phase 2, 06-2006-007

The improvements include placing asphalt millings, seal coat, and other incidental items; in accordance with the contract documents including Plans File Nos. 462-083/085, on 80th Avenue from Beardsley Street north to the end of the road, on Fleur Drive (85th Avenue) from Beardsley Street south to Blue Street, and on Blue Street from Fleur Drive (85th Avenue) east to R63 (95th Avenue).

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the hearing on the plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost for said improvement be closed; and that said plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost are hereby approved as the plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost for said improvement.

BE IT FURTHER RESOLVED: That the bid security of the unsuccessful bidders be and is hereby authorized and directed to be returned.



