WHEREAS, staff for the City (Operating Contractor) have indicated the Financial Services are provided by the Senior Budget Analyst reports to the City of Des Moines Public Works Director (WRA Director) and not to the City of Des Moines Finance Director; and

WHEREAS, the Senior Budget Analyst obtains assistance and guidance from the City of Des Moines Finance Director, it was determined by the Operating Contractor that the position needed to be an advocate for the WRA and not report to the City Finance Director; and

WHEREAS, on June 20, 2006, by Resolution No. 06-67, the WRA approved Amendment No. 2 to the WRA Operating Contract between the WRA and the City.
