The improvement includes removal of curb and gutter, pavement scarification, construction of PCC curb and gutter, HMA overlay, storm sewer, intakes, backfill of curb and site restoration all in accordance with the contract documents including Plan File Nos. 463-28/37 at Greenwood Park, 45th Street and Grand Avenue, Des Moines, Iowa.

The City Manager is hereby directed to sign said Permission to Sublet form granting permission for said listed subcontractor to work on said improvement upon each subcontractor's compliance with the City of Des Moines Contract Compliance Program as monitored by the Engineering Department.



On June 27, 2006, Grimes Asphalt & Paving Corp., J M Yonker, President, 12021 NW 54th Avenue, Grimes, IA 50111 submitted a proposal for construction of the Greenwood Park Street Improvements, Activity ID 11-2004-010, which the City Council has determined to be the lowest responsible, responsive bid for said project in the amount of \$123,016.75.
