The West 100 feet of Lot 44 CRAWFORD PLACE, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

Subject to any and all easements of record, utilities and or encroachments in place, and the right of entry to maintain and or reconstruct as required. This includes but is not limited to a 20' Permanent Storm Sewer Easement across the NW corner of said Lot 44 CRAWFORD PLACE.

- 2. A public hearing shall be held on July 28, 2008, at 5:00 p.m. in the City Council Chamber, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa. At that time the City Council will consider the above-described proposal during the public hearing.

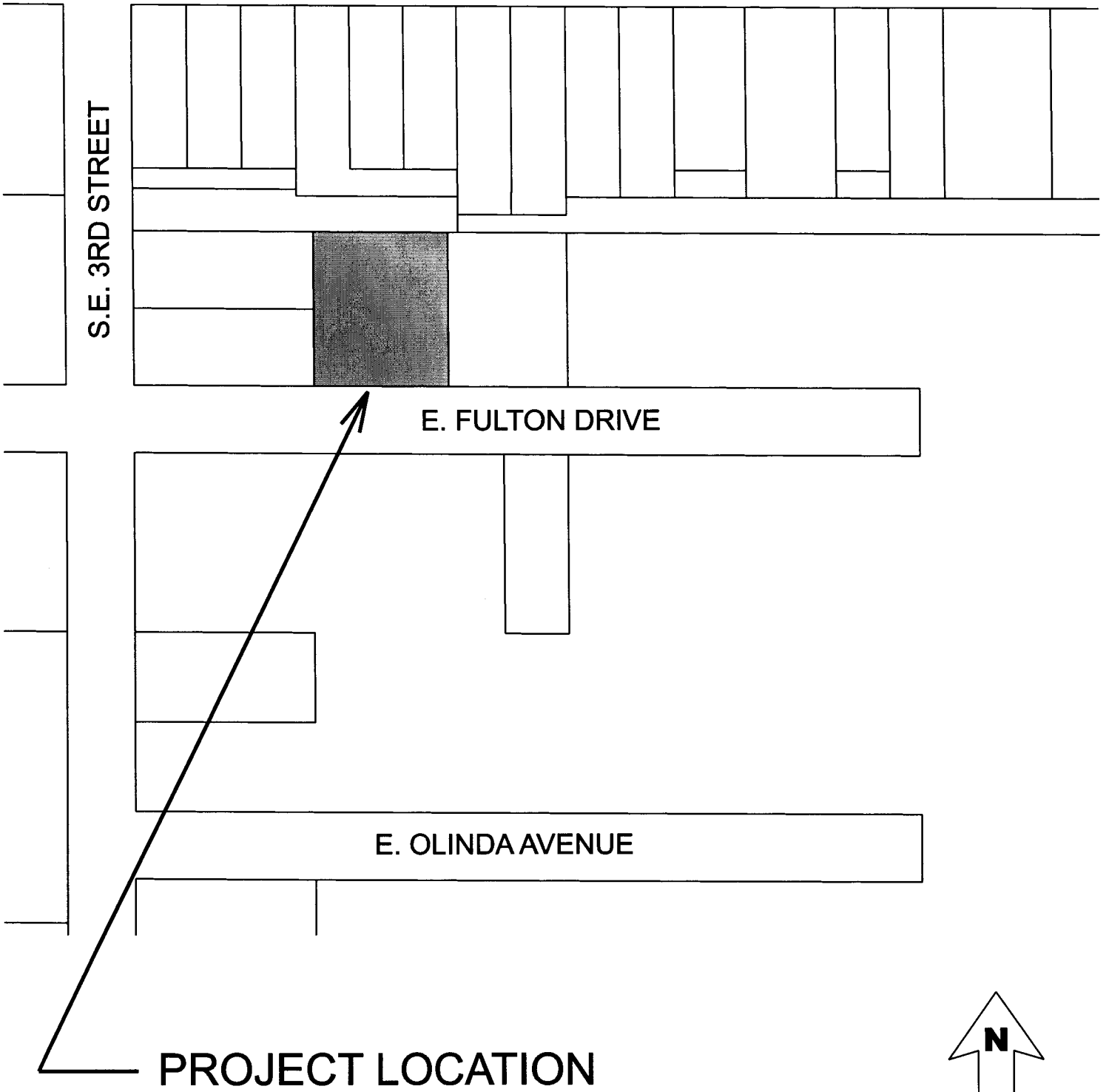

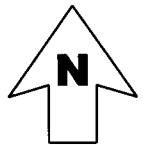


S.E. 3RD STREET
